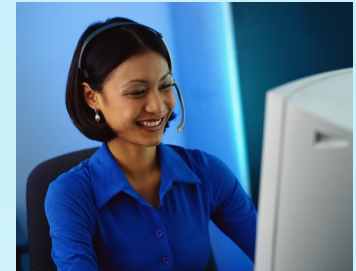

2021 IHCP Roadshow kicks off April 27

The Indiana Health Coverage Programs (IHCP) is hosting the 2021 IHCP Roadshow, a free virtual event, from April 27, 2021, through May 7, 2021. This bulletin contains details on the IHCP Roadshow sessions and panel discussions. Registration is not required to attend. On each day of the IHCP Roadshow, providers will be able to access the sessions and panel discussions through a Zoom link, which will be posted to the [2021 IHCP Roadshow](#) page at in.gov/medicaid/providers.



During the first 2 days of the IHCP Roadshow, the Office of Medicaid Policy and Planning (OMPP), Gainwell Technologies and each managed care entity (MCE) will give an introductory presentation highlighting new policies, programs and additional updates. The April 27 presentations will be repeated on Wednesday, April 28. Providers may choose to attend sessions on either day. See Tables 1 and 2 for details on the introduction presentations.
