## FSSA announces changes to LARC device billing for FQHC and RHC providers

The Indiana Family and Social Services Administration (FSSA) Office of Medicaid Policy and Planning (OMPP) will separately reimburse federally qualified health centers (FQHCs) and rural health clinics (RHCs) for long-acting reversible contraceptive (LARC) devices. LARC devices will be carved-out of the prospective payment system (PPS) rate.

FQHCs and RHCs should bill for LARC devices on a separate claim with the Healthcare Common Procedure Coding System (HCPCS) codes listed in Table 1. This change is effective **Nov. 1, 2022**, pending Centers for Medicare & Medicaid Services (CMS) approval. When approved, the OMPP will instruct Gainwell Technologies to reprocess claims with dates of service (DOS) on or after Nov. 1, 2022.



Table 1 – Procedure codes separately reimbursed for FQHCs and RHCs for DOS on or after Nov. 1, 2022

Procedure code	Description
J7296	Levonorgestrel-releasing intrauterine contraceptive system, (Kyleena), 19.5 mg
J7297	Levonorgestrel-releasing intrauterine contraceptive system, 52 mg, 3 year duration
J7298	Levonorgestrel-releasing intrauterine contraceptive system, 52 mg, 5 year duration
J7300	Intrauterine copper contraceptive
J7301	Levonorgestrel-releasing intrauterine contraceptive system, 13.5 mg
J7306	Levonorgestrel (contraceptive) implant system, including implants and supplies
J7307	Etonogestrel (contraceptive) implant system, including implant and supplies

FQHCs and RHCs should **not** bill using the HCPCS code **T1015** – *Clinic, visit/encounter, all-inclusive*. Providers can bill for LARC devices/supplies on the same day as an encounter that has a T1015 – but it must be billed on a separate claim.

After approval has been received from the CMS, claims for LARC devices that included the **T1015** code for dates of service on or after Nov. 1, 2022, will be reprocessed as a denied claim, and wrap payments will be recouped.
