# Pharmacy updates approved by Drug Utilization Review Board October 2023

The Indiana Health Coverage Programs (IHCP) announces updates to SilentAuth automated prior authorization (PA) system, PA criteria, Over-the-Counter (OTC) Drug Formulary, and Statewide Uniform Preferred Drug List (SUPDL) as approved by the Drug Utilization Review (DUR) Board at its Oct. 20, 2023, meeting.

## SilentAuth PA enhancement

The IHCP has enhanced its automated PA system to update the criteria for the Multiple Sclerosis Agents prior authorizations. These PA changes will be effective for PA requests submitted on or after Dec. 1, 2023. The PA criteria are posted on the *Pharmacy Prior Authorization Criteria and Forms* page on the Optum Rx Indiana Medicaid website, accessible from the *Pharmacy Services* page at in.gov/medicaid/providers.



PA criteria for Non-SUPDL PA and Step Therapy and Skyclarys were established and approved by the DUR Board. PA changes for Non-SUPDL PA and Step Therapy and Skyclarys apply to the fee-for-service (FFS) benefit. These PA changes will be effective for PA requests submitted on or after Dec.1, 2023. The PA criteria are



posted on the Pharmacy Prior Authorization Criteria and Forms page on the Optum Rx Indiana Medicaid website.

# **OTC Drug Formulary**

Updates to the OTC Drug Formulary were established at the Oct. 20, 2023, DUR Board meeting. See Table 1 for the list of products included on the formulary. The formulary is effective for dates of service (DOS) on or after Dec. 1, 2023, unless otherwise noted.

# Changes to the SUPDL

Changes to the SUPDL were made at the Oct. 20, 2023, DUR Board meeting. See Table 2 for a summary of SUPDL changes. Changes are effective for DOS on or after Dec. 1, 2023.
