## IHCP advises providers of compliance program resources

The Indiana Health Coverage Programs (IHCP) would like to advise IHCP providers of the compliance program resources that are offered free from the U.S. Department of Health and Human Services Office of Inspector General (HHS OIG). The [HHS OIG announced](#) that they developed the compliance program guidance documents (CPGs) as voluntary, nonbinding guidance documents to encourage the development and use of internal controls to monitor adherence to applicable statutes, regulations and program requirements.



The HHS OIG recently posted a new voluntary *General Program Compliance Guidance* (GPCG) on Nov. 6, 2023. The HHS OIG plans to update the other 14 voluntary CPGs at a later date.
