

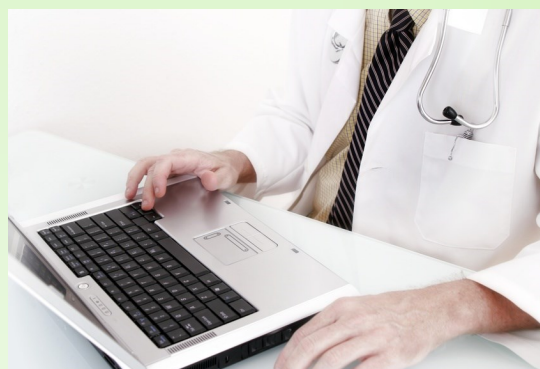

FSSA announces CMS approval for LARC device carve-out for FQHC and RHC providers

The Indiana Family and Social Services Administration (FSSA) Office of Medicaid Policy and Planning (OMPP) announces the approval from the Centers for Medicare & Medicaid Services (CMS) for the long-acting reversible contraceptive (LARC) device carve-out that was announced in *Indiana Health Coverage Programs (IHCP) Bulletin BT202309*. The IHCP will separately reimburse federally qualified health centers (FQHCs) and rural health clinics (RHCs) for LARC devices from the prospective payment system (PPS) rate. Changes are effective retroactively for dates of service (DOS) on or after **Nov. 1, 2022**.

FQHC and RHC providers are asked to bill the Healthcare Common Procedure Coding System (HCPCS) codes listed in Table 1 with place of service (POS) code 71 and **without** the HCPCS code **T1015** for DOS on or after **Nov. 1, 2022**. Providers can bill for LARC devices and supplies on the same day as an encounter that has a T1015 – but it must be billed on a separate claim.



For any claims that need to be resubmitted by the FQHC or RHC providers that deny for timely filing, please attach this bulletin as a waiver of timely filing and submit within 180 days of this publication date.

Table 1 – Procedure codes separately reimbursed for FQHCs and RHCs for DOS on or after Nov. 1, 2022

Procedure code	Description
J7296	Levonorgestrel-releasing intrauterine contraceptive system, (Kyleena), 19.5 mg
J7297	Levonorgestrel-releasing intrauterine contraceptive system, 52 mg, 3 year duration
J7298	Levonorgestrel-releasing intrauterine contraceptive system, 52 mg, 5 year duration
J7300	Intrauterine copper contraceptive
J7301	Levonorgestrel-releasing intrauterine contraceptive system, 13.5 mg
J7306	Levonorgestrel (contraceptive) implant system, including implants and supplies
J7307	Etonogestrel (contraceptive) implant system, including implant and supplies
