## IHCP announces new rates for DA and DDRS waivers, effective July 1, 2023

The Indiana Health Coverage Programs (IHCP) announces, effective July 1, 2023, the Division of Aging (DA) Aged and Disable (A&D) Waiver and the Traumatic Brain Injury (TBI) Waiver, along with the Division of Disability and Rehabilitation Services (DDRS) Community Integration and Habilitation (CIH) Waiver and the Family Supports Waiver (FSW) will have new rates, **pending approval** from the Centers for Medicare & Medicaid Services (CMS).

Providers are asked to begin billing with the new rates for claims with dates of service (DOS) on or after July 1, 2023. After the CMS approves the rates, Gainwell Technologies will mass adjust all claims for these home- and community-based services (HCBS) waivers with DOS on or after July 1, 2023. For any waiver claims that are submitted with the old rates with DOS on or after July 1, 2023, providers will be required to submit corrected claims to get paid the new rate. 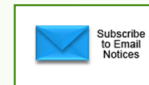
