### IHCP PA-UM contractor, Kepro, officially changes its name to Acentra Health

In *Indiana Health Coverage Programs (IHCP) Bulletin* <u>BT202301</u>, the Indiana Family and Social Services Administration (FSSA) announced Kepro as the new fee-for-service (FFS) prior authorization and utilization management (PA-UM) contractor for the IHCP, effective July 1, 2023.

Kepro is officially changing its name to Acentra Health. The name change is being made to reflect the merger between Kepro and CNSI (Client Network Services, Inc.), which occurred in December 2022. Acentra Health's PA-UM Provider Portal will continue to be called the Atrezzo Provider Portal. All previously announced information and training about the PA-UM transition remains the same. All features of the Atrezzo Provider Portal will also remain the same. Branding, website links and email addresses will slowly transition from Kepro to Acentra Health. Due to the slower



transition, providers will see communication from the contractor and the FSSA referring to either Kepro or Acentra Health. A more specific timeline of rebranding will be announced at a later date.

Providers can still register for the Provider Portal Administrator Training and the Provider Portal System Training. See *IHCP Bulletin* <u>BT202339</u> for dates and times and registration links.

## FAQ 1: How does it work if you already have Atrezzo portal access with another state's Medicaid plan?

Administrators can register the IHCP provider within the current login using the "Register New Provider" option under Setup, and entering the Indiana provider registration information.

#### FAQ 2: Can you have more than one administrator?

Yes, you can have as many group or provider administrators as you need. Just remember, the *group* administrators are over the entire provider group. The *provider* administrator is only over the one provider for which they are the administrator.
