IHCP removes coverage for Janssen COVID-19 vaccine and administration codes

On May 22, 2023, the Food and Drug Administration (FDA) revoked the emergency use authorization (EUA) for Janssen coronavirus disease 2019 (COVID-19) vaccines in the United States (see [FDA news release](#)).

In response to the FDA revocation, effective immediately, the Indiana Health Coverage Programs (IHCP) will not reimburse claims for the codes in Table 1 with dates of service (DOS) on or after **May 22, 2023**. Any claims that were paid for these codes for DOS on or after May 22, 2023, will be reprocessed and payment will be recouped.

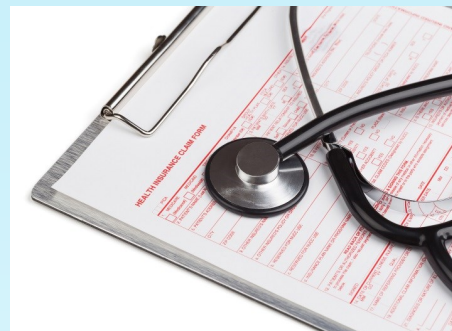


Table 1 – Janssen COVID-19 vaccine and administration codes noncovered for DOS on or after May 22, 2023

Procedure code	Description
91303	Severe acute respiratory syndrome coronavirus 2 (COVID-19) vaccine, DNA, spike protein, adenovirus type 26 (Ad26) vector, preservative free, 5x10 ¹⁰ viral particles/0.5mL dosage, for intramuscular use
0031A	Intramuscular administration of single severe acute respiratory syndrome coronavirus 2 (COVID-19) vaccine, DNA, spike protein, adenovirus type 26 (Ad26) vector, preservative free, 5x10 ¹⁰ viral particles/0.5mL dosage; single dose
0034A	Intramuscular administration of single severe acute respiratory syndrome coronavirus 2 (COVID-19) vaccine, DNA, spike protein, adenovirus type 26 (Ad26) vector, preservative free, 5x10 ¹⁰ viral particles/0.5mL dosage; booster dose
