IHCP announces correction to start date of new CMHW rates

The Indiana Family and Social Services Administration (FSSA) Office of Medicaid Policy and Planning (OMPP) was recently informed by the Centers for Medicare & Medicaid Services (CMS) that the rate changes for the Child Mental Health Wraparound (CMHW) State Plan benefit will not be able to take effect Oct. 1, 2023, as stated in *Indiana Health Coverage Programs (IHCP) Bulletin* [BT2023106](#).



The CMS has informed the state that the rate changes for CMHW cannot go into effect until after CMS has approved the amendment, which was Dec. 7, 2023. Providers may bill with the new rates listed in Table 1 for claims with dates of service (DOS) on or after Dec. 7, 2023. For CMHW claims being billed at the new rates, Gainwell Technologies will mass adjust all claims for these CMHW services with DOS on or after Dec. 7, 2023. For any CMHW claims that are submitted with the old rates with DOS on or after Dec. 7, 2023, providers will be required to submit corrected claims to get paid the new rate. Please note that Table 1 includes a rate increase for Respite Unexpected-Daily, which was not previously included in [BT2023106](#).

Fee-for-service (FFS) claims submitted for dates of service from Dec. 7, 2023, through Jan. 23, 2024, will be mass adjusted. Providers should see adjusted or reprocessed claims on remittance advices (RAs) beginning Jan. 23, 2024, with internal control numbers (ICNs)/Claim IDs that begin with 52 (mass replacements non-check related).
