## 2024 IHCP Roadshow to be held April 30 – June 6

The Indiana Health Coverage Programs (IHCP) will host the 2024 IHCP Roadshow at six locations throughout the state of Indiana, starting April 30 and concluding June 6.

The IHCP looks forward to using this year's Roadshow as an opportunity for continued relationship building between Indiana Medicaid providers and all IHCP entities. These events will allow for face-to-face discussion of current and future initiatives by the Indiana Family and Social Services Administration (FSSA), Gainwell Technologies and all of IHCP's business partners. This year's IHCP Roadshow will include special programming specifically on the launch of the Indiana PathWays for Aging program in addition to programming related to existing programs, payers and providers.



This year's Roadshow will be divided into a morning session with information targeted to PathWays providers with representation from the Office of Medicaid Policy and Planning (OMPP) and the three PathWays managed care entities (MCEs) and an afternoon session targeted to existing programs. Each session will include an Open House portion in which providers will have the opportunity to speak one-on-one with the FSSA and each business partner regarding the providers' specific questions and current partner initiatives. Providers are encouraged to come prepared with any policy-related questions.

The PathWays morning session will include the Open House period, a presentation by OMPP staff and a joint presentation by the PathWays MCEs. There will be a break for lunch and a second Open House period for providers in existing Indiana Medicaid programs. This will be followed by a second presentation by OMPP staff regarding other Medicaid programs and a presentation by each business partner associated with existing Medicaid programs.
