IHCP corrects error for VFC vaccine administration codes

The Indiana Health Coverage Programs (IHCP) discovered an error with the pricing for the Vaccines for Children (VFC) program vaccine administration codes as initially reported in *IHCP Bulletin BT202415*.

Claims reported with procedure codes listed in Table 1 for dates of service (DOS) on or after **Jan. 1, 2024**, processed before **March 28, 2024**, may have inappropriately denied with one of the following explanation of benefits (EOB) codes:

- 4014 Claim being reviewed for pricing
- 4209 No matching pricing segment for the procedure/ modifier combination billed on the CMS 1500 claim form



This change will be reflected in the next regular update to the Professional Fee Schedule, accessible from the https://linear.nlm.nih.gov/medicaid/providers.

The claim-processing system has been updated. Applicable claim details adjudicated through **March 28, 2024**, will be mass adjusted or mass reprocessed. Providers should see adjusted fee-for-service (FFS) claims on remittance advices (RAs) beginning June 26, 2024, with internal control numbers (ICNs)/Claim IDs that begin with 52 (mass replacements non-check-related). For claims that were underpaid, the net difference will be paid and reflected on the RA.

Table 1 – VFC vaccine administration codes that had rates corrected

Procedure code/modifier	Description
90471 SL	Administration of vaccine; VFC vaccine administration
90472 SL	Administration of vaccine, each additional vaccine; VFC vaccine administration
90473 SL	Administration of nasal or oral vaccine, 1 vaccine; VFC vaccine administration
90474 SL	Administration of nasal or oral vaccine, each additional vaccine; VFC vaccine administration
90480 SL	Immunization administration by intramuscular injection of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) (coronavirus disease [COVID-19]) vaccine, single dose; VFC vaccine administration
