Federal regulations related to the Department of Energy (DOE) funding requests require states, such as Indiana, who are applying for Weatherization Assistance Program funding, to prepare a State Plan as part of the application process. Another part of this process is providing the public an opportunity to review and comment on the contents of the State Plan.
