## HHF- Elimination of Blight Program

Blighted, vacant and abandoned homes are a serious issue for Indiana homeowners, neighborhoods and communities.

Governor Sue Ellspermann and Senator Jim Merritt (R-Indianapolis) are working in partnership to gather public feedback for a proposed expansion of the Hardest Hit Fund- Elimination of Blight Program to address abandoned and blighted properties throughout Indiana and have held a series of public forums to gather information on local community needs.
