The Northeastern Indiana Regional Coordinating Council (NIRCC) is the designated Metropolitan Planning Organization for the Allen County, Fort Wayne, and New Haven urbanized area. Every two years NIRCC produces a Transportation Improvement Program (TIP) that contains listings of transportation projects proposed to be undertaken over a five-year period. Many of the projects listed in the TIP will use federal funds from the Federal Highway Administration (FHWA) or Federal Transit Administration (FTA).

Federal regulations require that Metropolitan Planning Organizations (MPOs) publish an Annual Listing of Obligated Projects (ALOP) for which federal funds are being used for project development and construction. An obligated project has received authorization from a federal agency, and federal funds have been committed to the project. Projects for which funds have been obligated are not necessarily completed in the fiscal year, as projects can go through multiple phases including design and land acquisition prior to construction. The amount of the obligation will not necessarily equal the cost of the project due to phasing over multiple years, contract changes, and other unforeseen modifications.

The ALOP report documents the projects listed in the TIP that had federal funds obligated in fiscal year 2025. Fiscal year 2025 ran from July 1, 2024, to June 30, 2025. The report contains the detailed funding information for Local, Transit, and State projects that received federal funding in fiscal year 2025.

The Northeastern Indiana Regional Coordinating Council is not directly involved in the obligation of federal funds; therefore, this report is based on FHWA federal funding obligation information provided by the Indiana Department of Transportation. Projects with FTA funding reflect the project awarded amount through the grant approval process during the federal fiscal year and obligation information is provided by Citilink. These amounts are reflected in the *Net FY 2025 Federal Obligation* column.
