Greenways + Blueways 2020 Planning Begins *Public Encouraged to Complete Survey to Guide Process*

The Northwestern Indiana Regional Planning Commission (NIRPC) is developing an update to both the 2007 Greenways and Blueways Plan, and the 2010 Ped & Pedal Plan. The unified document, called Greenways + Blueways 2020, will provide a one-stop plan for NIRPC's planning for conservation, multi-use surface trails (greenways) and water trails



NIRPC is now asking the public to provide feedback about their preferences regarding the environment, multi-use surface trails and water trails (or blueways). NIRPC has made available an online survey and will have staff collecting responses on the region's trail network as well. Results of these surveys will be published in the upcoming plan, and will also be used

(blueways) in Northwest Indiana. This is the first time that a plan of this type has been developed by NIRPC.

"We are excited to finally bringing together these two related subject areas, which have been becoming increasingly intertwined at NIRPC over the years," said Mitch Barloga, NIRPC's Active Transportation Planner. "We plan to begin writing the plan this fall, with a draft ready for public comment by early 2016."

To kick off the planning process, a series of listening sessions were held throughout the region in May and June to gain input from both the public and stakeholders to help guide the development of the plan. These listening sessions included a brief presentation and a mapping exercise where participants were encouraged to mark down the locations of opportunities and challenges. From these meetings, NIRPC staff gained a wealth of information, creating a launch pad for moving the process forward. to expand and enhance outdoor experiences throughout Northwest Indiana.

Kathy Luther, NIRPC's Director of Environmental Programs, sees great potential in combining the plans. "When people are able to access nature, they gain a greater appreciation for the environment and conservation. There are also significant data showing improved education and health outcomes for those who have regular contact with natural areas. Linking transportation, recreation, and nature through planning helps stewardship and conservation in Northwest Indiana into the future."


NIRPC Office Renovations Update




The summer of 2015 has proven to be an interesting one for NIRPC. In late May, work began on updating and rebuilding NIRPC's office space. When finished, both NIRPC and the Northwest Indiana Forum will share the space once solely occupied by NIRPC. During the intervening months, NIRPC staff resided in the building's auditorium, lobby, and the current Forum space. Meetings, when held, have been at facilities such as Woodland Park and the Construction Advancement Foundation's safety training center.

Staff is getting settled into the newly renovated office space, and the remaining phases focusing on the auditorium and Forum spaces have commenced. Eventually, the City of Portage's Department of Community Development will move into the space currently occupied by the Northwest Indiana Forum.

As with any major renovation project, there has been some upheaval to the normal schedule of things. However, the generous assistance of NIRPC's partners has made this process go smoothly and allowed our work to continue.
