INTRODUCTION

The 2017 Annual List of Obligated Projects (ALOP) is a list of transportation projects in the Northwestern Indiana Regional Planning Commission (NIRPC) planning area for which Federal funds from the U.S. Department of Transportation were obligated during State Fiscal Year (SFY) 2017 (July 1, 2016 to June 30, 2017).

The joint transportation planning regulations of the U.S. Federal Highway Administration (FHWA) and Federal Transit Administration (FTA), published at 23 CFR 450.322, require that "...an Annual Listing of projects, including investments in pedestrian walkways and bicycle transportation facilities, for which Federal funds have been obligated in the preceding year shall be published or otherwise made available by the cooperative effort of the State, transit operator, and metropolitan planning organization for public review. The listing shall be consistent with the funding categories identified in each metropolitan transportation improvement program (TIP)."

An "obligation" is the Federal government's legal commitment to pay the Federal share of a project's cost. Prior to appearing on this list, a listed project must have been approved for federal funding by one of two operating administrations of the U.S. DOT—either the Federal Highway Administration (FHWA) or Federal Transit Administration (FTA). These projects are not necessarily initiated or completed in the program year, and the amount obligated will not necessarily equal the total cost of the project. For FTA projects, obligation occurs when the FTA grant is awarded. For FHWA projects, fund obligation occurs when a project agreement is executed and the State requests that the funds be obligated.

NIRPC is the metropolitan planning organization for the Indiana portion of the Chicago Urbanized Area and the Indiana portion of the Michigan City-LaPorte Urbanized Area. The NIRPC region includes Lake, Porter and LaPorte counties in Indiana. This list was produced by NIRPC in cooperation with the Indiana Department of Transportation and the public transit operators serving the three county area.

Construction Engineering (CE)	This expense is for an engineer to oversee construction to ensure that it is built as designed.
Utility Relocation Costs	This expense is for relocation of utilities that are in the construction zone.

Preventive Maintenance involves asphalt pavement treatments, such as a thin overlay, bonded wearing course, or chip-seal. A functional overlay involves removing several inches of asphalt and replacing it with the same amount (or greater) of new asphalt. Structural indicates improvement or correction of subsurface conditions.
Concrete Pavement Restoration (CPR)	Removal and full-depth replacement of deteriorated segments of concrete pavement.
Added Travel Lanes	Addition of travel lanes to an existing highway.
Bridge - Replacement	Replacement of the entire bridge, including piers, superstructure, deck, and other components.
Bridge - Repair or Restoration	Repair or Restoration of the entire bridge or major bridge components.
