

Introduction

Every year the Northwestern Indiana Regional Planning Commission (NIRPC) as the regional council of local governments (COG) and the Metropolitan Planning Organization (MPO) must publish for the public a list of projects that received federal funding for the past fiscal year. This list is called the Annual List of Obligated Projects or ALOP for short. NIRPC is organized under the provisions of Indiana Code 36-7-7.6 and its purpose is to institute and maintain a comprehensive planning and programming process for transportation, economic development, and environmental policy and provide a coordinative management process for the three counties. Thus, NIRPC is responsible for the transportation planning for the Northwestern Indiana urbanized area and the managing of all surface infrastructure transportation projects that have any of the following: a) federal funds; b) congestion and air quality impacts; or c) are regionally significant.

The FAST Act (Fixing America's Surface Transportation Act) was signed into law by President Barack Obama in 2015. This act provides long term funding certainty for surface transportation infrastructure planning and investment. The act continues (from the Moving Ahead for Progress in the 21st Century- MAP 21) the requirement that MPO's prepare an annual list of projects in which federal funds have been obligated for in the preceding year (23 U.S.C. of 49 U.S.C. Chapter 53). The Act further states that this list must be published within 90 days of the close of the preceding year. In Indiana, the fiscal year runs from July 1 to June 30. This Act is intended to increase the transparency of federal government spending on transportation projects within Metropolitan Planning Areas (MPA). Lake, Porter, and LaPorte Counties together constitute an MPA. This report fulfills this requirement for the fiscal year 2020.

This past year most of the transit operators received emergency federal funding through the Coronavirus Aid, Relief, and Economic Security Act (CARES Act). Much of this funding was for unplanned expenses and therefore was not in the original Transportation Improvement Program (TIP).

The term *obligation* in this report is the federal government's legal commitment to pay the federal share of a project's eligible costs. An *obligated project* is one that has been authorized by the Federal Highway Agency (FHWA) or the Federal Transit Administration (FTA) as meeting certain eligibility requirements for federal funds. For projects under FHWA jurisdiction, this obligation occurs when FHWA approves the project and executes the project agreement. For FTA projects, the obligation occurs when the FTA grant is awarded. Funds are considered obligated, even if no funds have been transferred or expended.


Once funds for a project have been obligated, the project's sponsor is able to begin incurring eligible expenses and then requests reimbursement. Each request must demonstrate that the recipient incurred the costs that are approved with the project agreement as well as federal guidelines. Obligations are not necessarily initiated or completed within the program year that it is stated. The amount of the obligation usually does not equal to total cost of the project. An obligation may be for only one phase of a project, and does not consider any other funds for the project such as local or private funds.

Where the funds were obligated

In fiscal year 2020, the federal government allocated \$230,430,146 for projects in Lake, Porter, and LaPorte Counties. This report includes a variety of sponsors, including Indiana Department of Transportation, counties, municipalities, transit operators, and NIRPC. The following graph shows the general type of projects that these funds were spent on. In general, obligated funds were spent in eight different areas:


- Bike/Pedestrian Facilities – Over \$9 Million
- Bridge Improvements – Almost \$33 Million
- Intersection Improvements (Congestion) – Over \$4 Million
- Intersection Improvements (Safety) – Over \$11 Million
- Roadway Improvements (Rehabilitation) – Over \$74 Million
- Roadway Improvements (Safety) – Almost \$1.3 Million
- Transit – Over \$80.5 Million
- Other Miscellaneous Projects – Over \$4.5 Million

The next graph displays where the funds were obligated in Northwestern Indiana (by county). For clarification, INDOT projects are indicated separately as to not confuse where the funding is being obligated. INDOT projects are only on state roads and are not controlled by local governments.
