## Call to Order and Pledge of Allegiance

# Approval of May 4, 2017 EMPC Minutes

On motion by Will Farrellbegg and second by Mary Tanis, the May 4, 2017 EMPC meeting minutes were unanimously approved as presented.

#### **Presentations:**

a. Grand Calumet River/Indiana Harbor Ship Canal Remedial Action Plan – Michael Spinar, IDEM An Areas of Concern (AOC) Program was established by the 1987 Great Lakes Water Quality Agreement. 43 areas were identified in the Great Lakes Basin as needing high levels of remediation with Remedial Action Plans (RAPS) required to be established for restoring the beneficial uses of these areas. The goal of the Remedial Action Plan is to complete management actions that will lead to the removal of the 14 beneficial use impairments (BUI) identified and the areas of concern delisting. Current management actions being performed include sediment remediation, habitat restoration and management, beach restoration, and aesthetics monitoring. Next steps include finalizing management actions for the remaining 11 beneficial use impairments by 2020, completing habitat management actions by 2020 and monitoring restoration progress.

# **NIRPC Business:**

Chairman Benson informed the Committee that the report involving federal budget cuts compiled during the EMPC meetings resulted in a letter developed by Kathy Luther being sent to the Legislative Committee. The budget proposed keeps changing, but the priorities have been forwarded to the Legislative Committee and are being considered.

Kathy announced the Chairman Benson is up for election for the President Elect of the National Association of Regional Councils (NARC).

Kay Nelson announced that Legacy Foundation has collected information from stakeholders regarding budgetary impacts and has been posted to a website.
