OVERVIEW

Basic Purpose and Background

The purpose of the proposed rules is to bring current fees, fines, civil penalties, financial benefit limitations, or other payment amounts set by an agency otherwise qualifying as a rule charged by the divisions of fish and wildlife and nature preserves into compliance with HEA 1623-2023 requiring the amounts to be placed in rule. The proposed rule makes those fees, fines, civil penalties, financial benefit limitations, and other payment amounts transparent for regulated persons under [IC 14](#).

(h) The fee for a dockside inspection is sixty-nine dollars (\$69) a year for a boat propelled primarily by sail carrying passengers for hire on a navigable water or an inland water of the state.

(i) The fee for a dry dock inspection is one hundred three dollars and fifty cents (\$103.50) for each inspection of a boat propelled primarily by sail carrying passengers for hire on a navigable water or an inland water of the state.
