Commission Members:

On August 11, 2023, the City of Fishers (City), through their attorney Christopher P. Greisl, filed a petition for rule change with the Natural Resources Commission (NRC) under Indiana Code section 14-15-7-3. The NRC accepted the petition and initiated the procedure under Information Bulletin #7. The Director of the Department of Natural Resources (DNR) assigned a committee comprised of David Bausman, DNR's General Counsel, John Gano, Conservation Officer with the Division of Law Enforcement, and Dan Carnahan, Fish Management Supervisor with the Division of Fish & Wildlife. The committee provides the following information and recommendation:

Background

The City requests a prohibited boating zone be amended to the "Geist Rule" (312 IAC 5-9-2) for the connected gravel pit to Geist Reservoir located at 39.949362; -85.916377 where the Geist Waterfront Park & Beach will boarder (see Exhibit A). The intended prohibited zone is being requested to last year-round and extend 600 feet from the shoreline of the Geist Waterfront Park or within 70 feet from the outermost boundary of the cove-line (see exhibit B). The City claims that this is needed to provide a safe environment and protect all patrons who access the Geist Waterfront Park & Beach for water and recreational activity.

Legal Standards IC 14-15-7-3 Adoption of rules; violations

Sec. 3. (a) The department may adopt rules under <u>IC 4-22-2</u> to implement this article concerning the following:

- (4) The safe operation of watercraft upon public water where unusual conditions or hazards exist, such as any of the following:
 - (A) An obstruction in or along public water.
 - (B) Watercraft traffic congestion.
 - (C) A beach, boat launch, marina, dam, spillway, or other recreational facility on or adjacent to public water.

- (6) The establishment of zones where the use of watercraft may be limited or prohibited for the following purposes:
 - (A) Fish, wildlife, or botanical resource management.
 - (B) The protection of users.

- (b) In a rule adopted under subsection (a)(4) or (a)(6), the department may establish a zone where:
 - (1) the operation of all or some types of watercraft is prohibited;
 - (2) particular activities are restricted or prohibited; or
 - (3) a limitation is placed on the speed at which a watercraft may be operated.
 - (c) A person who violates this section commits a Class C infraction.

Analysis

The committee provides the following analysis and supporting evidence from the Divisions of Law Enforcement and Fish & Wildlife:

1. Public Access

No surveys have been done in the past to determine boating traffic in the area in question. It is perceived that it would be a popular area for boaters and anglers to use if left open to recreational boaters and anglers. The Geist Waterfront Park & Beach is scheduled to be open from Memorial Day to Labor Day annually. Keeping the restriction in place throughout the year would limit access for recreational boaters and anglers to the cove for periods of time when the cove is not in use for swimming.

2. Safety issues

The committee agrees that the proposed no motorized boat zone would not create any additional safety hazards for recreational boaters on the reservoir since the area affected is already in a designated idle zone. However, as seen in exhibit B, the proposed closure zone projects into the boating channel that residents and boaters use for navigation. This area was inspected by the committee and found there to be boating hazards in the area consistent with shallow water and underwater obstructions which constricts this channel to a small area, especially when the reservoir's water level is low. It is recommended that the closure line should extend directly from point to point as shown by the red line in exhibit C.

3. Impacts to fish and wildlife

No impacts to fish and wildlife are anticipated with the rule amendment.

4. Public Waters

The Geist Waterfront Park and Beach cove is part of Geist Reservoir; and therefore, the Committee finds that it is a public water under IC 14-8-2-226. Currently, 312 IAC 5-9 contains boating regulations for public waters of Indiana. Under the code, rules have been established for specified public freshwater lakes, specified navigable waterways (other than Lake Michigan), Lake Michigan, specified waters owned by public utilities, and specified lakes and reservoirs with state or federal funding, and as previously noted, the Natural Resources Commission has already adopted boating restrictions for Geist Reservoir under 312 AIC 5-9-2.

5. Enforcement

Indiana Conservation Officers who regularly patrol the reservoir, as well as local law enforcement agencies, would be authorized to enforce the proposed no motorized boat zone under 312 IAC 5-9-2.

6. Public Access

The proposed request is for a no boating zone, which would include canoes, kayaks and paddleboards. Since the City has plans for a livery to rent non-motorized boats, the committee finds that their request is in conflict with their proposed park development plan that was included with the petition. Therefore, the committee finds that the petition request would need to be modified to a non-motorized boating zone to allow non-motorized boats in the requested zone.

Recommendation

The committee has determined that there is need for a boating restriction in the Geist Waterfront Park & Beach cove; however, since the City plans to operate a livery and wants to encourage non-motorized watercraft operation in the cove, the committee recommends that the restriction only be for a non-motorized boating zone.

In addition, the committee understands the need to regulate and provide safe recreational activities within the closure area; however, it also has to take into account that this is a reservoir with public access and recreation and should balance the safety with providing accessibility to other recreational users when the park is not in operation. Additionally, the need to not impede navigation in the boating channel is also a major concern based upon the proposed zone. When taking these factors into consideration, the committee recommends the closure line be modified from the petition to only be implemented as shown in exhibit C and only closed from the dates 14 days before Memorial Day to October 1st. The committee recommends adoption of the proposed rule language as bolded below within 312 IAC 5-9-2.

Section 312 IAC 5-9-2 - Geist Reservoir

Authority: IC 14-15-7-3

Affected: IC 14-15

Sec. 2.

- (a) This section establishes restrictions on the operation of boats in Geist Reservoir in Hamilton County, Marion County, and Hancock County.
- (b) A person must not operate a boat at greater than idle speed in any of the following locations:
- (1) East of a line seven hundred (700) feet west and parallel to the Olio Road causeway.
- (2) South of the Fall Creek Road bridge and causeway to a line one hundred (100) feet south and parallel to the western prolongation of the center line of 96th Street.
- (3) In an area known as Devil's Elbow and more particularly described as east, south, and upstream from a line extended shoreline to shoreline beginning at a point described as latitude 39°54' 42.0021756" north and longitude 85° 58' 12.826398" west; extending east northeasterly to a point described as latitude 39° 54' 43.20567" north and 85° 58' 5.5123356" west; and extending north northeasterly to a point described as latitude 39° 54' 47.1218976" north and 85° 58' 2.3784852" west.
- (4) In an area known as the Indianapolis Yacht Club Harbor and located east and southeast of a line within the southeast quarter of section 10 and part of the southwest quarter of section 11 in township 17 north, range 5 east, being more particularly described as beginning at a point which lies one hundred eighty (180) feet southeast from the east corner of the southeast abutment of the most westerly bridge over the reservoir, which point lies nineteen (19) feet northeast of the centerline of the pavement (assumed bearing of north fifty-four (54) degrees, ten (10) minutes west) of Fall Creek Road, thence across a bay of the reservoir north fifty-three (53) degrees, seventeen (17) minutes east one thousand one hundred eighty-six (1,186) feet, to the shoreline of the reservoir.

- (5) In an area known as the Indianapolis Sailing Club Harbor, within the southeast quarter of section 10, township 17 north, range 5 east, and being more particularly described as commencing at the southeast corner of section 10, thence west along the south line of the section a distance of three thousand five hundred (3,500) feet, thence north at right angles to the south section line a distance of three hundred eighty (380) feet to the point of beginning of the description in this subdivision (assumed bearing of north twenty-three (23) degrees, thirty-seven (37) minutes west), thence a distance of seven hundred forty-six and four-tenths (746.4) feet to the north end of a retaining wall along the shoreline of the reservoir, thence following the meanders of the shoreline of the reservoir northeasterly, southerly, and southwesterly to the point of beginning.
- (6) In an area known as Mast Head Bay, within the southeast quarter and part of the northeast quarter of section 9, township 17 north, range 5 east, and more particularly described as upstream and north of Fall Creek Road and east of Geist Road.
- (7) In an area known as Cocktail Cove.
- (8) North of 96th Street and west of Olio Road in Fall Creek Township, Hamilton County. The zone is the area east of an arc formed commencing at the point where the idle zone described in subdivision (4) intersects the east shoreline, then extending northward and connecting with the chain of islands and including the embayments east of the chain of islands, to a point four thousand (4,000) feet from the point of beginning.
- (9) In an area known as Juice Box Cove and more particularly described as an embayment east and southeasterly from a line extended shoreline to shoreline beginning at a point described as latitude 39° 56' 38.23" north and longitude 85° 55' 52.39" west; and extending southwesterly to a point described as latitude 39° 56' 37.33" north and longitude 85° 55' 53.61" west.
- (c) A person must not operate a boat within a rectangular area within the reservoir three hundred (300) feet and parallel to the concrete crest of the dam spillway and extending one hundred (100) feet along the dam from the east and west abutments of the dam spillway. The overall dimensions of the zone created by this subsection are three hundred (300) feet by seven hundred (700) feet.
- (d) No person shall anchor a boat or tie a boat to another boat (except to tow a boat from one (1) point to another) in a traveled portion of the reservoir so as to do either of the following:
- (1) Interfere with the safe passage of another boat.
- (2) Create a safety hazard to any person.
- (e) A person may not operate a motorboat at the Geist Waterfront Park & Beach Cove at the closure line between the coordinates:
 - (1) latitude 39.950009 and longitude -85.915834; and
 - (2) latitude 39.949934 and longitude -85.915334;

beginning fourteen (14) days before Memorial Day and ending October 1st.

CITY OF FISHERS, INDIANA PETITION FOR RULE CHANGE

The City of Fishers, Hamilton County, Indiana (the "City" or "Fishers"), by counsel, respectfully submits this Petition for Rule Change (the "Petition") to the Natural Resources Commission (the "Commission"). As further described herein, the City is requesting an amendment to 312 IAC 5-9-2 concerning Geist Reservoir (the "Geist Rule"). Specifically, the City requests a limited amendment to the Geist Rule by adding a prohibited boating zone designation (the "Prohibited Zone") in and around the City's newly constructed Geist Waterfront Park and Beach ("Geist Park & Beach"). Consistent with several prohibited boating zones created by the Commission near parks and public swimming areas throughout public waters in Indiana, the City's sole focus is to provide a safe environment and protect all patrons who access Geist Park & Beach for water and recreational activity.

I. GEIST PARK & BEACH WILL BE A WORLD CLASS AMENITY AND UNIQUE PARK EXPERIENCE FOR ALL TO ENJOY.

A. The City of Fishers is known as a "smart, vibrant, and entrepreneurial" community.

Fishers was named the "#1 Place to Live" in the United States by Money Magazine in 2017. Under the leadership of Mayor Scott Fadness, the City is known as a smart, vibrant, and entrepreneurial city through its neighborhood development, dedication to supporting high-growth companies and innovative city processes. Once a small bedroom community, Fishers is a fast-growing city of approximately 101,000 residents. Fishers is home to a dynamic business community with a growing number of life science and tech companies choosing to locate and expand in the City each year. Since 2014, approximately 8,100 new jobs have been committed and over \$2.5 billion in new investment has been made.

City leadership is intentional about creating unique experiences and destinations throughout the community. Fishers is home to over 700 acres of public recreation and park space, 131 miles of nature and multi-use trails, twenty-seven (27) park properties, sixty-one (61) sports

fields, 127-acre nature preserve, three (3) splash pads, and a vibrant Amphitheater that hosts both national recording artists and a variety of large community events throughout the year, including a best in class farmers market. Fishers' residents enjoy one-of-a-kind park experiences including the Fishers AgriPark, an innovative urban farm, and a national award-winning Maker Playground. Moreover, the Nickel Plate Trail is a linear trail that runs through the community with future connections to Indianapolis and Noblesville, and eventually connections to a larger regional trail network with the Monon and Midland Trails.¹

As more people have moved to and are working in Fishers, the City has creatively and efficiently managed its green spaces and park facilities to serve a growing population. As the City adds recreational amenities, its residents enjoy them. For example, the Nickel Plate District Amphitheater hosts more than one hundred (100) events each year and welcomes approximately 250,000 visitors per year. Fishers' award-winning Farmers Market hosts an average of 4,500 attendees each weekend during the summer season. Spark!Fishers, the annual community Independence Day festival, engages more than 20,000 residents each year. The City's 33-acre AgriPark produces over 600 tons of fresh food for the community and local food shelters. The City's parks department also has a vibrant partnership with Hamilton-Southeastern School Corporation. All 1,600 first graders in the school district engage in experiential learning trips to the Ritchie Woods Nature Preserve, with curriculum aligned with state standards delivered twice onsite at the park and once by City staff in each of the classrooms. Similarly, all 1,400 second grade students in the school district get to engage with the City's AgriPark, and all 1,600 fifth graders in the school district get to experience the City's Maker Playground.

i. Geist Park & Beach is a world-class amenity that will allow residents to engage and enjoy the reservoir.

The City has made significant investments in providing residents and visitors with the opportunity to access Geist. Geist Park & Beach adds to the City's list of robust, vibrant, and diverse recreational facilities. The park is being developed on the last significant, undeveloped parcel of Geist. Features of Geist Park & Beach include, without limitation, walking trails, open green space, a beach, and playground. Once developed, the park will provide the only public access to the reservoir.



The purpose of the park is to allow all Fishers residents to enjoy Geist without having to own a house or dock on the reservoir. Fishers Mayor Scott Fadness stated,

[t]he Geist area is one of Fishers' most distinct assets and this park sets forth a momentum for the long term sustainability of Geist Reservoir, its residents, and our community at large. In conversations with multiple residents and stakeholders, I've heard time and time again the argument that the long term vibrancy of Geist is a concern. Part of that involves environmental, boat traffic, and new development. My hope is that this park development helps

to mitigate those concerns for residents and turn Geist into a distinct asset for all of Fishers.²

The City has invested approximately Thirty Million Dollars (\$30,000,000) to develop Geist Park & Beach. On or around July 5, 2018, the City acquired approximately seventy (70) acres of real property previously owned by the Marina Limited Partnership ("MLP") and Irving Materials, Inc. ("IMI"), commonly referred to as 0 Olio Road, Fishers, Indiana 46040 (the "Real Estate"), for Fifteen Million Seven Hundred Sixty Thousand Dollars (\$15,760,000) (the "Acquisition"). Completing the Acquisition and securing the Real Estate was the City's first step to developing the park. Geist Park & Beach was designed by Browning Day Mullins Dierdorf, P.C., and is being constructed by Meyer Najem Construction, LLC.³



Geist Park & Beach will be built in phases,⁴ and is scheduled for a "soft opening" on or around April 22, 2023. The total construction cost for Phase I of the park is approximately

\$14,675,870 and will generally include the following: approximately 800 feet of fine sand shoreline; swimming and water recreation in the park's cove; public non-motorized boat launch (kayaks, canoes, paddleboards, etc.); non-motorized boat rental (kayaks, canoes, paddleboards, etc.); large pirate themed playground; swings, slides and a variety of other play structures for kids of all ages; sand and water play structures; restroom facilities, including an adult changing table; concession stand to purchase treats and snacks; trails; three (3) small shelters available for rental or public use; and one (1) large shelter available for rental or public use.







In order to support this amenity and its offerings, the City has made a substantial investment in staffing. The City has hired an Aquatics Manager who has the following qualifications: five (5) years' experience in high volume leadership focused on aquatic facility safety and leadership, including open water experience; Certified Lifeguard and Lifeguard Instructor; Certified Basic

Life Saver/ Oxygen/ First Aid Instructor; YUSA Swim Lesson and Swim Team Coach; Certified Pool & Spa Operator; and American Red Cross Lifeguard certification, with open water guarding endorsement which includes advanced AED/ First Aid/ Oxygen training.


Geist Park & Beach will be supported by five (5) head lifeguards, thirty-five (35) regular lifeguards, and various public works staff including laborers, maintenance technicians, foreman, and a superintendent. In general, lifeguards will be on duty 10:00 am- 8:00 pm daily, Memorial Day- Labor Day for the community to enjoy Geist.

II. ESTABLISHING A PROHIBITED BOATING ZONE ON GEIST IS CONSISTENT WITH THE HISTORICAL OPERATIONS OF THE RESERVOIR AND OTHER BOATING PROHIBITIONS RECOGNIZED BY THE COMMISSION TO ENSURE SAFETY IN AND AROUND PUBLIC SWIMMING AND BEACH AREAS.

A. Boats have not been operated within the park's cove for nearly fifty years.

The intent of the City's Petition is to provide a safe environment for its residents and visitors of Geist Park & Beach, which the Commission has routinely recognized throughout the Geist Rule.⁵ The Prohibited Zone is tightly construed and would only prohibit the operation of a boat within (i) the park's cove, and (ii) within an area immediately adjacent to the park where the cove intersects with the main water.

As previously discussed, IMI owned and operated the Real Estate until July, 2018, where it utilized the property for mining activity. For at least forty-four (44) years, the cove was enclosed. In other words, boat operators could neither enter the cove through the main water nor did they rely upon the cove to gain access to Geist.

As part of the City's Acquisition, and to satisfy a prior real estate commitment, IMI "punched" a hole through the cove, connecting the cove to the main water for the first time in the summer/fall 2018. Shortly thereafter, the construction of Geist Park & Beach commenced.



An approximate depiction of the Prohibited Zone is included above (**in purple**).⁷ As you may notice, the above-referenced depiction contains temporary construction material (**red line connecting the cove**), which was utilized to control water flow during construction of the beach.⁸ The northern boundary of the Prohibited Zone is nearly identical to the temporary construction material. In other words, even after IMI connected the cove to the main water, boat operators have continued to understand that the cove is inaccessible to boat traffic. Accordingly, the City's Prohibited Zone is consistent with nearly fifty (50) years of boating operations on Geist.

B. The Prohibited Zone will not negate private access to Geist.

Geist Park & Beach is located East of Olio Road, and in accordance with the Geist Rule, a person may not operate a boat at greater than idle speed in this area.⁹ As further depicted below, this section of Geist generally consists of wetlands and two channels, where deeded dock owners



within certain residential neighborhoods access the main water.¹⁰ The Prohibited Zone does not terminate access to the main water (i.e., the City is **not proposing** to close a channel). Instead, the City merely seeks to prohibit boating operations within the park's cove to protect the beach and public swimming area. Again, because the park's cove has been inaccessible to boating operations for nearly fifty (50) years, the City is not infringing upon a private right of access that previously existed.

Moreover, the Prohibited Zone has been narrowly tailored to avoid interference with the existing channels utilized by deeded dock owners to access the main water. As further depicted above, deeded dock owners who access Geist East of Olio Road will continue to utilize the same routes and channels (generally depicted with red lines above) to access the main water of the

reservoir. Consistent with nearly fifty (50) years of boating operation on Geist, boats will not need to utilize the park's cove to access the reservoir, and the Prohibited Zone will not negatively impact boat access to the main water.

C. Consistent with other prohibited boating zones recognized by the Commission, the City seeks to provide a safe and welcoming environment for those who attend its beach and public swimming area.

The Commission has frequently recognized the need to create prohibited boating zones on public waters throughout Indiana to ensure the safety of its patrons. Specifically, the Commission has frequently prohibited the operation of boats in and around beaches and public swimming areas. For example, the Commission has created prohibited boating zones near beaches and public swimming areas throughout various Public Freshwater Lakes, including Bass Lake¹¹ and the Lake James Chain of Lakes;¹² and throughout Lake Michigan, including areas within Lake County,¹³ Porter County,¹⁴ and LaPorte County.¹⁵

Geist and Morse Reservoir ("Morse") represent half of the public waters specified under 312 IAC 5-9 - Specified Waters Owned by Public Utilities ("Rule 9"). Similar to Geist, Morse is owned by Citizens for the purpose of providing drinking water to Central Indiana. Rule 9 provides Morse with three (3) prohibited boating designations:

(1) Within three hundred (300) feet and parallel to the concrete crest of the dam spillway for the reservoir. (2) Within two hundred (200) feet from the shoreline of **South Harbor beach**. (3) Within two hundred (200) feet from the shoreline of **Morse Park beach**. ¹⁷

(emphasis added). Analogous to its "sister-lake", the City respectfully requests the Prohibited Zone be added to the Geist Rule barring the operation of a boat within the park's cove. This prohibition is consistent with the clear and unambiguous intent of the Commission to create safe environments for beaches and public swimming areas throughout public waters in Indiana.

III. <u>CONCLUSION</u>

The City has made a tremendous investment in providing a world-class amenity to its community. The City's Petition, and the creation of the Prohibited Zone, is consistent with the Commission's long history of protecting beaches and public swimming areas on public waters throughout Indiana, and nearly fifty (50) years of boating operations on Geist.

WHEREFORE, the City of Fishers, by counsel, respectfully requests the Petition to be granted, the Prohibited Zone to be created, and for all other just and proper relief.


[Proposed Coordinates of the Prohibited Zone and Draft Rule Amendment]




Approximate Buoy Locations at Each Pin Drop









Approximate Distance from Shoreline of Cove

312 IAC 5-9-2 Geist Reservoir

Authority: IC 14-15-7-3 Affected: IC 14-15

- (a) This section establishes restrictions on the operation of boats in Geist Reservoir in Hamilton County, Marion County, and Hancock County.
- (b) A person must not operate a boat at greater than idle speed in any of the following locations:
 - (1) East of a line seven hundred (700) feet west and parallel to the Olio Road causeway.
- (2) South of the Fall Creek Road bridge and causeway to a line one hundred (100) feet south and parallel to the western prolongation of the center line of 96th Street.
- (3) In an area known as Devil's Elbow and more particularly described as east, south, and upstream from a line extended shoreline to shoreline beginning at a point described as latitude 39 54' 42.0021756" north and longitude 85' 58' 12.826398" west; extending east northeasterly to a point described as latitude 39' 54' 43.20567" north and 85' 58' 5.5123356" west; and extending north northeasterly to a point described as latitude 39' 54' 47.1218976" north and 85' 58' 2.3784852" west.
- (4) In an area known as the Indianapolis Yacht Club Harbor and located east and southeast of a line within the southeast quarter of section 10 and part of the southwest quarter of section 11 in township 17 north, range 5 east, being more particularly described as beginning at a point which lies one hundred eighty (180) feet southeast from the east corner of the southeast abutment of the most westerly bridge over the reservoir, which point lies nineteen (19) feet northeast of the centerline of the pavement (assumed bearing of north fifty-four (54) degrees, ten (10) minutes west) of Fall Creek Road, thence across a bay of the reservoir north fifty-three (53) degrees, seventeen (17) minutes east one thousand one hundred eighty-six (1,186) feet, to the shoreline of the reservoir.
- (5) In an area known as the Indianapolis Sailing Club Harbor, within the southeast quarter of section 10, township 17 north, range 5 east, and being more particularly described as commencing at the southeast corner of section 10, thence west along the south line of the section a distance of three thousand five hundred (3,500) feet, thence north at right angles to the south section line a distance of three hundred eighty (380) feet to the point of beginning of the description in this subdivision (assumed bearing of north twenty-three (23) degrees, thirty-seven (37) minutes west), thence a distance of seven hundred forty-six and four-tenths (746.4) feet to the north end of a retaining wall along the shoreline of the reservoir, thence following the meanders of the shoreline of the reservoir northeasterly, southerly, and southwesterly to the point of beginning.
- (6) In an area known as Mast Head Bay, within the southeast quarter and part of the northeast quarter of section 9, township 17 north, range 5 east, and more particularly described as upstream and north of Fall Creek Road and east of Geist Road.

- (7) In an area known as Cocktail Cove.
- (8) North of 96th Street and west of Olio Road in Fall Creek Township, Hamilton County. The zone is the area east of an arc formed commencing at the point where the idle zone described in subdivision (4) intersects the east shoreline, then extending northward and connecting with the chain of islands and including the embayments east of the chain of islands, to a point four thousand (4,000) feet from the point of beginning.
- (9) In an area known as Juice Box Cove and more particularly described as an embayment east and southeasterly from a line extended shoreline to shoreline beginning at a point described as latitude 39° 56' 38.23" north and longitude 85° 55' 52.39" west; and extending southwesterly to a point described as latitude 39° 56' 37.33" north and longitude 85° 55' 53.61" west.
- (c) A person must not operate a boat in the following locations:
- (1) Within a rectangular area within the reservoir three hundred (300) feet and parallel to the concrete crest of the dam spillway and extending one hundred (100) feet along the dam from the east and west abutments of the dam spillway. The overall dimensions of the zone created by this subsection are three hundred (300) feet by seven hundred (700) feet.
- (2) Within six hundred (600) feet from the shoreline of Geist Waterfront Park & Beach.

[or]

- (2) Within seventy (70) feet from the outermost boundary of the cove-line of Geist Waterfront Park & Beach.
- (d) No person shall anchor a boat or tie a boat to another boat (except to tow a boat from one (1) point to another) in a traveled portion of the reservoir so as to do either of the following: (1) Interfere with the safe passage of another boat. (2) Create a safety hazard to any person.

It is requested that this information be submitted sixty (60) days prior to the expiration date to initiate construction. SANITARY SEWER SYSTEM DESCRIPTION

The proposed project shall consist of approximately 787 feet of 8-inch diameter PVC SDR-35 (ASTM D3034) gravity sanitary sewer, a new lift station, and approximately 1,529 feet of 4-inch diameter PVC (AWWA C900) force main to serve a parking area and recreational development at the referenced project location. The average design flow for this project is 50,000 gpd. The proposed force main will be connected to an existing 8-inch diameter sanitary sewer located at the northeast corner of the intersection of Olio Road and Waterway Boulevard. The proposed lift station will consist of a new 7-foot diameter wet well and 6-foot diameter valve vault. The wet well will contain two submersible pumps each rated for 334 gpm @ 68 feet TDH.

Inspection during construction, maintenance after completion and wastewater treatment will be provided by the City of Fishers.

CONDITIONS AND LIMITATIONS TO THE AUTHORIZATION FOR CONSTRUCTION OF SANITARY SEWERS

During the period beginning on the effective date of this permit and extending until the expiration date, the permittee is authorized to construct the above described sanitary sewer system. Such construction shall conform to all provisions of State Rule 327 IAC 3 and the following specific provisions:

PART I

SPECIFIC CONDITIONS AND LIMITATIONS TO THE CONSTRUCTION PERMIT

Unless specific authorization is otherwise provided under the permit, the permittee shall comply with the following conditions:

- 1. Any local permits required for this project, along with easement acquisition, shall be obtained before construction is initiated.
- 2. If pollution or nuisance conditions are created, immediate corrective action will be taken by the permittee.
- 3. The separation of sanitary sewers from water mains and drinking water wells must comply with 327 IAC 3-6-9.
- 4. All gravity sewer pipe must be leak tested using either a hydrostatic test or air test in accordance with 327 IAC 3-6-19(d). If using a hydrostatic test, the rate of exfiltration or infiltration shall not exceed 200 gallons per inch of pipe diameter per linear mile per day. Air test shall be as prescribed.

- 5. The results of the gravity sewer leakage test and/or force main leakage test on the completed sewer shall be submitted to this office within three months of completion of construction.
- 6. Deflection tests must be performed on all flexible* pipe after the final backfill has been in place at least 30 days. No pipe shall exceed a vertical deflection of 5%. Deflection test results shall be submitted with the infiltration/exfiltration test results. (*The following are considered nonflexible pipes: vitrified clay pipe, concrete pipe, ductile iron pipe, cast iron pipe, asbestos cement pipe.)
- 7. Manholes shall be air tested in accordance with ASTM C1244-93, Standard Test Method for Concrete Sewer Manholes by the Negative Air Pressure (Vacuum) Test. The manhole test results shall be submitted with the gravity sewer leakage test results.
- 8. An audio-visual alarm shall be installed for the proposed lift station.
- 9. Air relief valves shall be installed at high points in the force main.
- 10. All force mains must be pressure and leak tested in accordance with 327 IAC 3-6-19(e).

Failure to submit test results within the allotted time period or failure to meet guidelines as set forth in the above conditions could be subject to enforcement proceedings as provided by 327 IAC 3-5-3.

GENERAL CONDITIONS

- 1. No significant or material changes in the scope of the plans or construction of this project shall be made unless the following provisions are met:

 - c. Submit revised plans and specifications including a revised design summary; and
 - d. Obtain a revised construction permit from this agency.
- 2. This permit may be modified, suspended, or revoked for cause including, but not limited to the following:
 - a. Violation of any term or conditions of this permit:
 - b. Obtaining this permit by misrepresentation or failure to disclose fully all relevant facts.
- 3. Nothing herein shall be construed as guaranteeing that the proposed sanitary sewer system shall meet standards, limitations or requirements of this or any other agency of state or federal government, as this agency has no direct control over the actual construction and/or operation of the proposed project.
