Bloomington Municipal Water rate case: Consumer comments invited, Public hearing Nov. 29

If you would like to comment on the City of Bloomington's proposed water rate increase, you have a couple of opportunities to do so.

The Indiana Office of Utility Consumer Counselor (OUCC) is inviting written comments for the case record. In addition, the Indiana Utility Regulatory Commission (IURC) will hold a public field hearing on Tuesday, November 29, 2016.

The IURC's November 29 hearing will start at 6:00 p.m. in the Tri-North Middle School Auditorium (1000 W. 15th St. in Bloomington).

- Consumers will be able to speak directly to the Commission, under oath and on the record, regarding the water rate case.
- Consumers will also be able to submit written comments for the case record.
- Comments will carry equal weight whether they are oral or written.
- Commissioners are not allowed to answer questions during the field hearing. However, OUCC staff will be available before, during and after the hearing to address questions about the process.

Bloomington's current water rates were approved in 2011. Under the city's request, monthly water charges for a residential customer using 5,000 gallons per month would increase from \$22.09 to \$26.93 if the customer lives within the city limits. An out-of-city residential customer with the same usage would see his or her water charges rise from \$23.19 to \$28.27. The city is also seeking IURC approval to issue up to \$4.6 million in long-term debt.

According to its testimony and exhibits, the utility is seeking the changes due to increases in operating and maintenance costs, the need to replace aging mains, proposed treatment plant improvements, and additional proposed capital improvements.

As of January 1, 2016, the average monthly residential rate for water utilities under IURC jurisdiction was \$31.48 for 5,000 gallons.

Only Bloomington's water rates are at issue in this case. State law restricts the IURC's oversight of municipal water utilities to their rates, charges, and finances.

Indiana law does not give the IURC jurisdiction over municipal sewer utilities, leaving oversight of municipal sewer rates to locally elected city and town councils.

The OUCC – the state agency representing consumer interests in cases before the IURC – is scheduled to complete its review of the city’s request and file testimony on December 15, 2016.

The OUCC needs to receive all written consumer comments no later than December 8, 2016 so that it can: 1) Consider them in preparing its testimony and 2) File them with the Commission to be included in the case’s formal evidentiary record.
