## Edwardsville Water Corp. rate case: Consumer comments invited

The Indiana Office of Utility Consumer Counselor (OUCC) is inviting written comments from Edwardsville Water Corporation customers on the utility's pending rate request.

The OUCC – the state agency representing consumer interests in cases before the Indiana Utility Regulatory Commission (IURC) – is reviewing the utility's request and has not yet taken a position in this case. The OUCC is scheduled to complete its review and file testimony with the Commission on October 7, 2015.

Edwardsville Water Corporation is a not-for-profit utility serving more than 4,000 customers in Floyd and Harrison Counties. Its request would raise the monthly residential bill for 5,000 gallons from \$38.19 to \$46.07. The utility is also seeking IURC approval to issue up to \$3 million in long-term debt.

According to its testimony, the utility is requesting the changes for a number of reasons including paying for capital improvements. Projects noted in testimony include water main additions and replacements, a new booster station, a new supply well, replacement of heavy equipment, and upgrades to billing and meter reading systems. Edwardsville Water Corporation's current rates were approved in 2011.

A technical evidentiary hearing in this case is scheduled for December 2, 2015 at the PNC Center (101 W. Washington St.) in Indianapolis. While IURC evidentiary hearings are open to the public, participation is typically limited to attorney and Commission questioning of witnesses who have filed technical, written testimony on behalf of the case's formal parties.
