## **Boonville Natural Gas Rate Case: Consumer Comments Invited**

If you want to comment on Boonville Natural Gas Corporation's proposed rate increase, you are invited to do so.

The Indiana Office of Utility Consumer Counselor (OUCC), the state agency representing consumer interests in cases before the Indiana Utility Regulatory Commission (IURC), is reviewing the utility's request and is scheduled to file its report with recommendations on Mar. 4, 2024.

Current base rates for Boonville Natural Gas – a privately-owned utility providing service to more than 4,900 customers in Warrick County - received IURC approval in 2019.

According to its filing, the utility is seeking the rate increase due to higher operating and maintenance costs. The proposal would raise annual revenues by approximately \$1.04 million and would increase monthly residential bills as follows:

Monthly Usage	Current Gas Bill	Proposed Gas Bill
20 Therms	\$28.72	\$35.34
50 Therms	\$52.33	\$67.08
100 Therms	\$91.70	\$120.00

Each residential gas bill includes a monthly \$13.80 customer service charge which does not vary based on usage. It would rise to \$15.00 under the utility's request. The remainder of the bill varies by customer usage.

The base distribution rates at issue in this case comprise approximately 53% of a typical Boonville Natural Gas customer's residential bill. They cover "non-gas" costs such as operating and maintenance expenses and capital infrastructure improvements. The remaining 47% of a typical monthly bill pays for the natural gas itself, which the utility recovers on a dollar-for-dollar basis subject to OUCC review and IURC approval every six months.

Boonville Natural Gas Corp. has filed this case through the IURC's Small Utility Filing Procedure, which is designed to reduce the time and expense involved with regulatory filings for utilities with fewer than 8,000 customers. Savings are gained by allowing utility staff to use standardized forms and forego a technical evidentiary hearing. This is designed to result in utilities needing less assistance from rate consultants or attorneys, leading to fewer expenses to be passed on to customers.

The OUCC uses the same standard to review a utility's operations and records whether it seeks a rate increase through the Small Utility Filing Procedure or a traditional case. Conducting its analysis on behalf of all utility consumers, the OUCC will present its recommendation through a report to the IURC. The IURC's review is conducted on behalf of the public interest (a balancing of utility and customer interests); it is responsible for resolving any factual disputes that may arise and issuing a final order establishing new rates.

A settlement agreement is possible in any legal proceeding; such an agreement, if reached, would require IURC approval. Any agreement can be approved, denied, or modified, with the settling parties required to demonstrate that it is in the public interest.
