East Chicago Sewer Rate Case: OUCC Invites Consumer Comments *Change of Location for IURC Public Hearing on Jan. 11*

If you would like to comment on the Sanitary District of East Chicago's pending rate request, you have the chance to do so.

The Indiana Office of Utility Consumer Counselor (OUCC), the state agency representing consumer interests in cases before the Indiana Utility Regulatory Commission (IURC), is reviewing the utility's request and is scheduled to file testimony on Feb. 9, 2022.

The OUCC continues to invite written consumer comments for the case record. In addition, the IURC's Jan. 11, 2022 public field hearing in this case - originally scheduled at the East Chicago Public Library's Main Branch - will be held in the East Chicago Common Council Chambers at 4525 Indianapolis Blvd. The hearing starts at 6:00 p.m., local time.

Written consumer comments

While using its legal and technical resources to review the district's request, including examining the utility's books and operations, the OUCC is inviting written comments from customers through Feb. 2, 2022.

The OUCC needs to receive all written consumer comments no later than Feb. 2, 2022, so that it can: 1) Consider them in preparing its testimony and 2) File them with the Commission to be included in the case's formal evidentiary record. Comments should include the consumer's **name, mailing address**, and a reference to either "**IURC Cause No. 45632**" or "**Sanitary District of East Chicago**."

Public field hearing

The IURC's public field hearing on the district's request is now scheduled for Tuesday, Jan. 11, 2022, at East Chicago City Hall (4525 Indianapolis Blvd.). The hearing is scheduled to begin at 6:00 p.m., local time, in the Common Council Chambers and is statutorily required in this case.

Consumers are encouraged to arrive by 5:45 p.m. for an overview of field hearing procedures and the rate case process. Attendees are required to comply with all local health and safety regulations.

The field hearing's sole purpose is to receive public testimony.

- Consumers can speak directly to the Commission under oath and on the record.
- Oral comments during the hearing will become part of the case record. They will carry the same weight as written consumer comments the OUCC receives by Feb. 2, 2022.
- Utilities do not make presentations or answer questions during field hearings. The focus, again, is on public input. In this case, the district filed testimony and exhibits in October 2021.
- Commissioners are not allowed to answer questions about the case. They will ultimately render a decision after weighing evidence from the utility, the OUCC, and intervening parties.
- No final decisions will be made at the field hearing.

Sworn comments presented at the field hearing will carry the same weight as written consumer comments filed by the OUCC.

Case overview

The Sanitary District of East Chicago is requesting a three-phase sewer rate increase. The utility's request, if approved, would raise the monthly residential sewer bill for a customer using 5,000 gallons from \$20.60 to \$26.21 when an order is issued in 2022, to \$30.36 on Sept. 1, 2023, and then to \$31.53 on Sept. 1, 2024.

In its filings, the utility states it is seeking the increase to cover higher operating and maintenance costs, along with improvements to aging infrastructure, including ultraviolet disinfection at the wastewater treatment plant, pump replacements, pump station rehabilitation, and lagoon improvements.

Current rates for the Sanitary District of East Chicago received city council approval in 2015. Indiana law allows the district to seek rate changes from either the IURC or the East Chicago Common Council.

The average monthly residential rate for sewer utilities under IURC jurisdiction is \$57.81.

A settlement agreement is possible in any legal proceeding. If an agreement is reached, the settling parties are required to present evidence showing it to be in the public interest. The IURC may approve, deny, or modify any settlement it considers.

A final Commission order is currently expected in July 2022.

Water rates and charges are not at issue in this case.
