Dr. Riba explained that he is currently licensed in both Tennessee and Illinois. His Illinois controlled substance registration is currently on probation. He is currently working on obtaining a hearing in Illinois to have the probation lifted as he has met all their

requirements.

His DEA in Illinois is on a MOA for three (3) years with conditions.

Back in 2006 because Dr. Riba said he didn't know the difference between deep sedation and conscience sedation a five (5) year old girl crashed after he put her under. He called 911 and the patient was taken to the hospital and passed away a few days later.

He also indicated that he didn't discuss the sedation with the family to get any family history of issues with sedation. He later found out their son had severe issues with sedation while in the hospital.

The Illinois Board acted on his CSR stating he shouldn't have used deep sedation on the patient, which goes beyond his scope of practice. They suspended his dental license, revoked his dental sedation permit. His CSR had been expired since 1997. He renewed it in 2019 and it was renewed on probation.

Right after his suspension in Illinois, he applied to a Tennessee dental license and was issued a limited license to serve in an unserved area. He practiced in TN until he was able to practice again in Illinois.

Mr. Rhine testified to the dates of the incident and dates of actions taken in Illinois.

The Indiana Dental Board issued his license free and clear.
