Brad Ray, Associate Professor, Wayne State University School of Social Work Director, Center for Behavioral Health and Justice – INSPECT Report:

Mr. Ray appeared telephonically regarding this matter.

At the June 2020 Board meeting, Mr. Ray was approved for INSPECT data and the Board requested he return in six (6) months to give them an update on his report.

The following is the information provided in his original appearance back in June.

He is the Director of the Center for Behavioral Health and Justice at Wayne State University, and he has funding from CDC (through ISDH) to develop and examine novel approaches to overdose surveillance data. He works closely with the Indiana Management Performance Hub (MPH) who conducts the necessary record linkage between disparate statewide data sets, removes identifying information, and then provides the data to him in a secure Enhanced Research Environment (ERE). Within the ERE he is able to conduct statistical analysis and then seek permission (from MPH) to remove the analysis for write-up. This approach provides top-notch data security and assures that no individual information is ever seen or disseminated. For this project he is requesting approval to share the INSPECT data with ISDH. What this means is that MPH will access the INSPECT and ISDH datasets (which includes vital records and toxicology data) for record linkage and then provide the nonidentifiable information to him through the ERE for subsequent analysis. His goal in this project is to use the ISDH and INSPECT data to determine the role, if any, of dispensed prescription medications among accidental drug overdose deaths and whether there are patterns over time and space with overlaps in the data. Preliminary data suggest that less than 6% of those who die from an accidental drug overdose death die from a substance that was dispensed through INSPECT; in fact, most individuals die from illicit or diverted substances. Only his linking INSPECT and ISDH data can we examine this pattern statewide. He has prior experience working with the linked INSPECT data with MPH and would continue to defer to them on data governance concerns.

He reviewed information from 2016 to 2020 and linked the toxicology results to accidental deaths. Approximately 420 deaths in 2020 were a result of overdoses.

The Board thanked him for the update and ask that he return in six (6) months for another update.

Brian Jent, J.D., Hall, Render, Killian, Heath & Lyman / Ascension St. Vincent — Discuss preparing & providing drugs for infusion:

INSPECT Report - Kara Slusser, INSPECT Director

INSPECT clinical alerts have been updated to maintain consistency with the CDC's guidelines. Practitioners will receive an alert via email and PMP AWARXE if any of their patients exceed the following thresholds within any sixty (60) day period. Practitioners must log into AWARXE to review the patient information. Alerts will remain in the practitioner's account for ninety (90) days.

The first alert is for multiple provider episodes. It generates an alert when a patient meets or exceeds five (5) prescribers and five (5) Dispensers within a sixty (60) day period. The second alert is a daily active MME threshold. It generates an alert when the daily active MME (Morphine Milligram Equivalent) is greater than or equal to one-hundred twenty (120). The third alert is for overlapping prescriptions. It generates an alert when opioids and benzodiazepines are prescribed concurrently to a patient. Each alert is sent out with a disclaimer and an explanation.

Kara Slusser, INSPECT Director and Zaneta Nunnally, Compliance Director requested to use CSR Funds to pay for recertification for Ms. Nunnally and Mr. Tim Thomas's CISCI recertification. They will be taking the CriticalPoint training for Sterile Compounding. The cost is \$60.00 per person and the certification will be good for three (3) years.
