#### **Remote dispensing consideration – ScriptCenter Locker System – Dawn Moore R.Ph., VP of Pharmacy, IU Health:**

Let the record reflect that Donna Wall did not participate in this matter, she reviewed application files.

The following appeared to discuss the ScriptCenter Locker System:

- Laura Lord, R.Ph., Julie Thornton R.Ph., Cindy Miller R.Ph., Edward Rickert, J.D. and Dawn Moore, R.Ph., VP of Pharmacy, IU Health.

They are looking at placing these in Methodist and Riley Hospitals

The potential positive impact:

- Increase ease of prescription pick-up
  - Increase adherence rates
  - Improve employee satisfaction
  - Increased access for difficult to find medications for discharge patients
- Free up time for pharmacy staff for:
  - Counseling patients
  - Developing patient/pharmacist relationships
  - Improve safety

Statement of explanation:

- At their retail locations, ScriptCenter will be primarily implemented for:
  - Employee pickup
  - Discharge patient pickup
- Implementation of ScriptCenter will:
  - Allow prescription pick up 24/7
  - Reduce pharmacy lines and wait times for employees and clinic or discharge patients waiting to go home.

- Leads to improving access: Patients discharged with difficult to find medications will have access afterhours, potentially reducing readmission rates
- How ScriptCenter works:
  - Prescriptions are received, filled, labeled and verified in the pharmacy according to applicable law using their current prescription filling policy and workflow process
  - Once verified by a pharmacist medications are linked to a barcoded container and securely transported and loaded into ScriptCenter
  - The patient receives a notification that their prescriptions are ready. The patient is also notified if any counseling is required.
  - Patient logs into ScriptCenter using two (2) unique identifiers to pick up and pay for their prescriptions. Counseling is offered and prescriptions are released once the patient has received counseling.
- Security Features:
  - Kiosk:
    - Weighs 1,300 lbs and requires identification for pharmacy personnel to access
    - Monitored by on-site hospital security personnel 24/7
    - External security cameras monitoring the location 24/7
  - Anti-diversion controls & procedures:
    - Electronic monitoring – ScriptCenter uses a variety of reports to ensure 100% prescription tracking.
    - Photo and signature captured for every prescription pick up.

After he was licensed as a Pharmacist he had a relapse and his pharmacist license was suspended. After a period of suspension, he got his Pharmacist license back, but relapsed again shortly after he got his license back.

Ms. Patel stated that she began as PIC for this facility on May 15, 2015. The previous PIC allowed an unlicensed technician to work in the pharmacy. The technician had passed the PTCB and they thought that was all that was needed.

FDA visited the facility. They found that they were only checking 60% Endotoxins seriality testing and it needed to be 100% checked. The facility is now making sure 100% is checked.

They have not (did not) receive any complaints from any States. They send about 1,500 per year in to Indiana.

**Major Hospital Pharmacy – 600000096A Pharmacy Renewal:**

A representative appeared before the Board regarding a positive response on the facilities license renewal and was represented by counsel, Brian Betner, J.D.

Kelly Connolly, R.Ph., P.I.C. and John (Jack) Horner, CEO both appeared on behalf of Major Hospital Pharmacy.

The diversion happened prior to the Hospital moving into their new facility. The new facility with upgraded security features in the pharmacy, including multiple cameras and the Pyxis C-II Safe.

The response/action plan was/is:

- Pharmacist only access to narcotic room (badge access) and C-II Safe (BioID)
- Installation of multiple cameras in the narcotic room and medication rooms
- Implementation of Pyxis C-II Safe
- Implementation of additional Pyxis Med-Stations throughout the facility



- All controlled substances, C-II through C-V, are stored in the Pyxis C-II Safe, with the exception of phenobarbital
- Blind count used for inventory of controlled substances
- Daily audits of Pyxis override list and Pyxis vs C-II Safe compare reports
- Reports of discrepancies involving controlled substances immediately addressed.
- Random audits on controlled substance usage routinely performed by pharmacy and nursing
- Education for nursing and pharmacy staff during credentialing, unit meetings, and Net Learning.

### INSPECT Report – Kara Slusser, Inspect Director:

PMPi:

- One of the goals of the INSPECT program this year is to increase the number of States sharing PDMP data with Indiana. They have reached out to Rhode Island, North Carolina and Tennessee in the last month to start the process of connecting through PMP InterConnect. Rhode Island will be the first state to integrate PDMP data into pharmacy management systems within CVS Pharmacy. Since Indiana will be integrating with CVS this year, we'll be working to connect to additional States that also have a large integration initiative to ensure interoperability between integrated chains in various States.

Upcoming Conferences:

- From April 2<sup>nd</sup> through the 5<sup>th</sup>, Kara will be in Atlanta attending the National Rx Drug Abuse and Heroin Summit.

NAMSDL:

- Kara has been invited to participate in Prescription Drug Monitoring Program Resource Group, which was created in 2016 by the National Alliance for Model

State Drug Laws (NAMSDL). NAMSDL will host two (2) in-person meetings of the Resource Group. The first meeting will be held in Wisconsin on June 7<sup>th</sup>. This is an opportunity for PDMP Administrators to collaborate on issues important to our states including:

- Changes to laws, rules, and policies that will facilitate specific program improvements;
- Key educational points about PDMPs for policymakers and appropriate others;

#### **Pending Legislation: As of March 8, 2018**

##### **Senate Bill 52** Low THC extract.

Status: Passed Senate 35-13; Passed House with amendments 93-0; Referred to Conference Committee Provides that the Indiana department of state revenue (department) may revoke a registered retail merchant's certificate if the department has good cause to believe a retailer has sold or is selling low THC extract and the product is not derived from industrial hemp. Repeals all provisions concerning the cannabidiol registry and a "substance containing cannabidiol" (all added by HEA 1148-2017). Defines "low THC extract" as a product derived from Cannabis sativa L. that contains not more than 0.3% THC and no other controlled substances. Establishes requirements for the manufacture and sale of low THC extract. Provides that a person commits the offense of dealing in marijuana, hash oil, hashish, or salvia as a Level 5 felony if the: (1) person is a retailer; (2) marijuana, hash oil, hashish, or salvia is packaged in a manner that appears to be low THC extract; and (3) person knew or reasonably should have known that the product was marijuana, hash oil, hashish, or salvia. Makes conforming amendments.

##### **Senate Bill 74** Controlled substances.

Status: Passed Senate 46-1; Passed House with amendments 91-0; Senate concurred; awaiting Governor signature

Adds Mexedrone to definition of "synthetic drug"

Adds the following drugs to Schedule I – opiates:

- Acrylfentanyl
- Cyclopentyl fentanyl
- Isobutyryl fentanyl
- Methoxyacetyl fentanyl
- Ocfentanil

- Ortho-fluorofentanyl
- Para-chloroisobutyryl fentanyl
- Para-fluorobutyryl fentanyl
- Para-methoxybutyryl fentanyl
- Tetrahydrofuranyl fentanyl
- Valeryl fentanyl

Adds the following drugs to Schedule I – hallucinogenic substances

- Deschloroketamine
- 4-Hydroxy-MET
- N-methyltryptamine

Adds the following drugs to Schedule I – depressants

- Flubromazolam

Adds the following drugs to Schedule II – hallucinogenic substances

- Dronabinol

**Senate Bill 221** INSPECT program.

Status: Passed Senate 47-1; Passed House with amendments 95-0; Senate concurred; waiting Governor signature

Allows a dispenser of ephedrine, pseudoephedrine, or a controlled substance to transmit certain information to the INSPECT program by any electronic method that meets specifications prescribed by the state board of pharmacy (board). Provides that, to the extent considered appropriate by the board, the INSPECT data base must be interoperable with other similar registries operated by federal and state governments. Requires the following practitioners to obtain information about a patient from the data base before prescribing an opioid or benzodiazepine to the patient: (1) A practitioner who has had the information from the data base integrated into the patient's electronic health records. (2) Beginning January 1, 2019, a practitioner who provides services to the patient in the emergency department of a hospital or a pain management clinic. (3) Beginning January 1, 2020, a practitioner who provides services to the patient in a hospital. (4) Beginning January 1, 2021, all practitioners. Provides that a practitioner is not required to obtain information about a patient who is subject to a pain management contract from the INSPECT data base more than once every 90 days. Removes lapsed provisions. Provides that beginning January 1, 2019, a practitioner who is permitted to distribute, dispense, prescribe, conduct research with respect to, or administer ephedrine, pseudoephedrine, or a controlled substance in the course of the practitioner's professional practice or research must be certified to receive information from the INSPECT program. Allows a practitioner to request a waiver from the requirement of checking the data base before prescribing an opioid or benzodiazepine if the practitioner does not have access to the Internet at the practitioner's place of business. Requires the Indiana state board of pharmacy to: (1) establish a process for a practitioner to request a waiver; (2) determine whether to grant a practitioner's request for a waiver; and (3) issue a waiver when the board determines a waiver is warranted. Requires Board of Pharmacy to: 1) establish a process to request a waiver; 2) determine whether to grant a waiver; and 3) issue waivers when warranted.

**Senate Bill 225** Continuing education requirements.

Status: Passed Senate 49-0; Passed House 94-0; waiting Governor signature

Establishes continuing education requirements for licensed health care practitioners who apply for a controlled substances registration. Provides that the continuing education requirements expire July 1, 2025.

**Senate Bill 410** Advanced practice registered nurses.

Status: Passed Senate 47-0; Passed House with amendment 94-0; Senate concurred; waiting Governor signature

Replaces the term "advanced practice nurse" with "advanced practice registered nurse" throughout the Indiana Code. Requires the Indiana state board of nursing to adopt rules concerning educational and



certification requirements that an advanced practice registered nurse must meet to be authorized to prescribe drugs.

**House Bill 1130** Professional Licensing Agency matters.

Status: Passed House 94-1; Passed Senate with amendment 49-0; Referred to Conference Committee  
Among other things, allows the board of pharmacy to issue a provisional wholesale drug distributor license to an applicant that is located in Indiana and is in the process of obtaining accreditation or certification. Requires a third party logistics provider to be licensed by the board of pharmacy before engaging in third party logistics. Provides for certain requirements to be fulfilled prior to licensing for a third party logistics provider. Requires the board of pharmacy to adopt rules for licensing of third party logistic providers. Makes technical and conforming changes.

**House Bill 1214** Low THC hemp extract

Status: Passed House 93-0; Passed Senate with amendment 37-12; Referred to Conference Committee  
Repeals all provisions concerning the cannabidiol registry and a "substance containing cannabidiol" (all added by HEA 1148-2017). Defines "low THC hemp extract" as an industrial hemp product derived from Cannabis sativa L. that contains not more than 0.3% delta-9-THC (including precursors) and no other controlled substances. Establishes requirements for the manufacture, labeling, and sale of low THC hemp extract. Provides that the Indiana department of state revenue may revoke a registered retail merchant's certificate if the retailer sells a product falsely labeled as low THC hemp extract. Provides that a retailer commits dealing in marijuana as a Level 5 felony if: (1) the retailer sells marijuana; (2) the marijuana is packaged in a manner that appears to be low THC extract; and (3) the retailer knows or reasonably know that the product is marijuana. Makes possession of marijuana a Class A misdemeanor if: (1) the marijuana is packaged in a manner that appears to be low THC hemp extract; and (2) the person knows or reasonably should know that the product is marijuana.

**House Bill 1317** Health matters.

Status: Passed House 91-1; Passed Senate with amendment 36-12; Referred to Conference Committee  
Among other things, provides that a pharmacy or pharmacist has a right to provide individuals with information concerning the individual's cost share for a prescription drug. States that a pharmacy or pharmacist cannot be proscribed by a third party administrator, a health insurer, or a health maintenance organization from discussing the information or from selling to the individual a more affordable alternative. Prohibits a copayment for a drug under the state employee health plan, an accident and sickness insurance policy, or a health maintenance organization contract from exceeding the amount payable to the pharmacy for the drug under an agreement with the pharmacy. Requires the board of pharmacy to adopt rules concerning telepharmacy under the laws regulating remote dispensing facilities. Exempts from the law regulating pharmacists and pharmacies the delivery of peritoneal renal dialysis related supplies by manufacturers, third party logistic providers, and wholesale drug distributors in certain circumstances.

- Medication therapy management – with the Governor's office
- Sterile Compounding – with Governor's office for initial review
- Tele-pharmacy rules – drafting in progress
- Non-Sterile Compounding rules – drafting in progress.
