Cassie McDaniel, Investigator with the Attorney General's Office was sworn in as a witness. Ms. McDaniel testified that she did the investigation into this matter.

February 2017, he entered into a diversion agreement with Kentucky when he was charged with two (2) counts of Assault in the third (3rd) degree, Class D Felony. He entered into a pretrial diversion agreement for three (3) years.

On his 2018 license renewal he did not report the above arrest.

March 11, 2023 he was charged with the following:

- Battery against a Public Safety Officer Felony 6
- Battery on a Person less than 14 years old Felony 6
- Domestic Battery Misdemeanor A
- Resisting Law Enforcement Misdemeanor A

On July 25, 2023 a warrant was issued for his arrest as he failed to appear in court to face the above charges.

July 14, 2023 he was charged in Florida with the following:

- Count 1: On July 14, 2023 in the State of Florida without lawful authority did forcibly, secretly or by threat, confine, abduct or imprison F.S.J. and/or A.J., against that person's will, with the intent to inflict bodily harm or terrorize the victim or another person, contrary to Florida Statute 787.0l(l)(a)3. (1 DEG FEL, (10)
- Count 2: On July 14, 2023 in the State of Florida, did actually and intentionally touch or strike against the will of, a person 65 or older,, and in doing so used a motor vehicle, a deadly weapon, contrary to Florida Statute 784.045(1)(a)2 and 784.08. (I DEG FEL)
- Count 3: On July 14, 2023 in the State of Florida did knowingly enter or remain in a dwelling, with the intent to committee an offense therein and in the course of committing the burglary, Derek Jordan committed assault or battery (1 DEG FEL)

On June 5, 2024, he was sentenced in Florida to Forty (40) months in Department of Corrections, with credit of three hundred thirty-two (332) days followed by five (5) years' probation and must complete several classes as well as a mental health exam.

She indicated that in the body camera recording received from the Franklin Police department you can hear Dr. Jordan admitting that he takes all kinds of drugs.

His order states the following:

• James Pucka is ordered to complete his four (4) hour continuing education

- requirement in public health or risk management, as specified under 846 Ind. Admin. Code 1-8-1, focusing on courses that address professional boundaries.
- James Pucka shall appear for QUARTERLY appearances before the Board.
- James Pucka is ordered to never treat female patients without a non-family female staff member being present in the treating room at all times. The staff member shall sign a document created by the Spine Worx Company that affirms their oversight for each female patient James Pucka treated. The affirmations for each treatment shall be available for the board to review at each quarterly appearance.
- Any complaint associated with inappropriate comments or touching by James
 Pucka made on the Spine Work Patient Experience form or the Employee
 Complaint Form or analogous form shall be submitted to a neutral party not
 associated with the Spine Worx business and said neutral party shall submit the
 Complaint to IPLA Board Director Jody Edens. Any complaint can be emailed to

Dr. Pucka brought in a binder of completed forms for all female patients he has seen since his last appearance. The form has been updated to what the Board requested. He stated that he does have a female employee with him at all time he sees a female patient.

The Board asked the Board Director, Jody Edens if she has received any complaints regarding Dr. Pucka. She stated she has not received any.

Dr. Pucka said he sees about 60-70 patients per day.

The Board asked Dr. Pucka about his Acupuncture license if he received it back from the Medical Board. He indicated he did not as they wanted to see what the Chiropractic Board did. He is not practicing acupuncture.

After discussion, the Board determined that Dr. Pucka was in compliance with his probation order.
