They are requesting a variance in which a technician can check the work of another technician. The technician checking the work would check what was pulled and put into the machine, then it leaves the pharmacy. The nurse would then check it at the patient's bedside.

The checking technician would have to work 20 hours per week and have been employed with the pharmacy for 1 year to be eligible. They must achieve a 99.8% error free during their training.

Mr. White indicated this is a request for a variance of the Boards statute and the Board can't grant a variance of statues.

The Hospital/Nurse will be the final check as the Nurse checks the medication before giving it to the patient, therefore a variance is not needed.

The Board requested Mr. Martirosyan return in December 2018 to give the Board some statistics of this procedure.

#### The potential positive impact:

- Increase ease of prescription pick-up
  - Increase adherence rates
  - Improve employee satisfaction
  - Increased access for difficult to find medications for discharge patients
- Free up time for pharmacy staff for:
  - Counseling patients
  - Developing patient/pharmacist relationships
  - Improve safety

#### Statement of explanation:

- At their retail locations, ScriptCenter will be primarily implemented for:
  - Employee pickup
  - Discharge patient pickup
- Implementation of ScriptCenter will:
  - Allow prescription pick up 24/7
  - Reduce pharmacy lines and wait times for employees and clinic or discharge patients waiting to go home.
  - Leads to improving access: Patients discharged with difficult to find medications will have access afterhours, potentially reducing readmission rates
- How ScriptCenter works:
  - Prescriptions are received, filled, labeled and verified in the pharmacy according to applicable law using their current prescription filling policy and workflow process
  - Once verified by a pharmacist medications are linked to a barcoded container and securely transported and loaded into ScriptCenter
  - The patient receives a notification that their prescriptions are ready. The patient is also notified if any counseling is required.
  - Patient logs into ScriptCenter using two (2) unique identifiers to pick up and pay for their prescriptions. Counseling is offered and prescriptions are released once the patient has received counseling.
- Security Features:

#### Kiosk:

- Weighs 1,300 lbs and requires identification for pharmacy personnel to access
- Monitored by on-site hospital security personnel 24/7
- External security cameras monitoring the location 24/7

#### Anti-diversion controls & procedures:

- Electronic monitoring ScriptCenter uses a variety of reports to ensure 100% prescription tracking.
- Photo and signature captured for every prescription pick up.

This will be for employees and patients discharged after hours. Counseling will be done upon pick-up for employees, discharged patients will be seen prior to their discharge. There is a screen for counseling and it cannot be seen; they also have the option of using a phone so no one can hear it.

IPLA's Compliance Officer has completed the inspection with a passing grade.

They are requesting to open a tele-pharmacy in Albien, Indiana. It is located forty-five (45) minutes from the nearest Pharmacy in Warsaw.

They will have technicians working in the tele-pharmacy. The technician at the Albien store will take pictures and que them by computer to the Pharmacist in Warsaw who will check the prescription. Once the pharmacists checks the prescription the technician in Albien will put the prescription on the rack for the patient to pick up.

If a consultation is needed, the patient can step to the right and where the panel is and will talk with the Pharmacist in Warsaw by screen. It is a full size monitor with the option to use a phone or use the speakers by talking directly to the monitor. Both sides can see each other.

They will carry some over the counter drugs and some medical equipment.

The Pharmacist will be there on scheduled days to give vaccines and to do routine inspections.

The tele-pharmacy will be open Monday through Friday 9:00 a.m. to 6:00 p.m. and Saturday 9:00a.m. to 2:00p.m.

They have two (2) technicians splitting the time with one (1) to two (2) others to cover for time off.

The building will be locked and a sign posted that they are closed for lunch.

Carol Ott, PharmD, BCCP, Clinical Professor of Pharmacy Practice, Clinical Pharmacy Specialists, Psychiatry, Eskenazi Health/Midtown Community Mental Health, Purdue University College of Pharmacy, and David Butterfield, PharmD, BCPS, PGY2 Psychiatric Pharmacy Resident Research Presentation regarding Gabapentin use:

Ms. Ott and Mr. Butterfield were before the Board in September 2017:

Ms. Ott stated that Gabapentin has become an issue over the last seven (7) to eight (8) years.

Ohio requires it to be reported to their PDMP program. Virginia legislature passed a law to require it to be reported to their PDMP program Kentucky made is a schedule V drug.

#### Gabapentin: Indicators of Misuse:

- A study in the US found that 22% of 162 study participants with opioid use disorder had a prescription for gabapentin
- Of these, 40%, used higher than prescribed doses
- Gabapentin has been found in 1% of drug-related deaths in Scotland
- Cross-sectional studies of opioid abuse in UK and US samples found gabapentin misuse to be 15% 22% of the sample
- "Street market" demand for gabapentin for misuse of the drug itself and as a cutting agent for heroin
- Street market" price \$1.00 \$7.00 per table depending on dose
- Increase ER visits by 90% since 2008 (Drug Abuse Warning Network)

#### Systematic Review (2017):

- Gabapentin abuse has been studied in 23 epidemiologic studies since 2010
- More prevalent in past or current opioid abusers (1.1%) and in those with an opioid use disorder (15% -22%)
- Poison center data in 2014 noted 116 overdose cases reported, usually co-ingestion with other substances
- 2 fatal overdoses were with gabapentin alone highest reported overdoses were 11,500 mg and 91,000 mg
- One study of prison inmates with psychiatric diagnoses and substance use disorder suggested 16% rate of gabapentin misuse

## Objectives of this research were:

- Explain the similarities between gabapentin and pregabalin
- Identify the predicators for misuse of gabapentin
- Describe the patients on gabapentin within Indiana Medicaid
- Assess the potential for misuse of gabapentin within Indiana Medicaid

#### Gabapentin Misuse:

- 2012 report in UK found gabapentin prescribing increased by 150%
- Street demand for gabapentin \$1.00 \$7.00 per tablet
- Has been used on the streets as a cutting agent with heroin
- Virginia/Ohio require prescription drug monitoring reporting for gabapentin
- Kentucky beginning July 2017 scheduled gabapentin as a controlled V substance

## Study purpose:

• To provide descriptive information relative to Indiana Medicaid members 18 years of age and older receiving prescriptions for gabapentin

#### Data collection:

 Retrospective data was collected on patients with claims for gabapentin patients with claims for gabapentin through Indiana Medicaid from October 1, 2014 to September 20, 2016.

## Study methods:

- Inclusion Criteria:
  - Use of gabapentin between October 1, 2014 to September 30, 2016
  - Age 18 years or older
  - Indiana Medicaid member
- Exclusion Criteria:
  - Younger than 18 years of age
  - No gabapentin fills within the study time frame

### Study Endpoints:

- Primary Endpoint:
  - Evaluation of diagnoses for the use of gabapentin in individuals within Indiana
     Medicaid during the designated study time frame
- Secondary Endpoint:
  - Characterization of the study population
  - Analysis of individuals receiving greater than the maximum daily dose (>3600 mg)
  - Analysis of gabapentin dose (>3600 mg) in individuals receiving concomitant MAT therapy.

#### Study Implications:

- Gabapentin is most commonly prescribed to middle-aged white females
- Gabapentin was utilized for off-label or no indication in 77.5% of cases
- Gabapentin prescriptions were not commonly written for >3600 mg per day

#### **AWARXE**

- As you may know, the Center for Disease Control (CDC) updated its NDC file last fall. As a result, they eliminated the buprenorphine morphine milligram equivalency (MME) value. This would cause a significant impact in automated MME calculations for patients who have buprenorphine in their prescription history. To avoid confusion, our vendor made the following changes to the AWARxE system on April 11th:
  - **a.** Buprenorphine will be excluded from displayed MME calculations.
  - **b.** The patient report will display MMEs for opioids (excluding buprenorphine) and include information on buprenorphine in mg/day instead of MME.

## **INSPECT Funding Request**

• The Indiana Professional Licensing Agency would like to purchase an annual subscription for the American Hospital Formulary Service, known as AHFS Drug Information. The American Society of Health-System Pharmacists (ASHP) developed and published this drug information table, which has been the foundation for organizing drug formularies in institutional, governmental, and other settings since 1959. AHFS is currently used as the basis for drug classification within AWARXE. To maintain consistency and accuracy in State prescription drug data reports, MPH will need a copy of the AHFS Drug Information. IPLA can purchase a subscription to the AHFS Drug Information from ASHP for an annual fee of \$1,000. We request permission from the Board to utilize INSPECT funds for this purchase.

## **PMP** Interconnect

• INSPECT is now connected to Rhode Island. The two States are actively sharing PDMP data. This decision was made as part of a multi-State integration effort with CVS, which Indiana plans to participate in later this year.

### **INSPECT Integration Initiative**
