II. ADOPTION/AMENDMENTS OF THE AGENDA

III. PERSONAL APPEARANCES

A. Initial Application

1. David Gurley, M.D. – Failure to Disclose

Gurley was unable to appear and will be rescheduled.

2. Andrew Hoffman, M.D. – Positive Response

Hoffman appeared for a positive response on his initial application. When he applied, he had three open medical malpractice cases. He has been working in Illinois doing locums work and is waiting on a permanent position in Terre Haute. There was no action taken against his Illinois license due to the medical

malpractice cases. A motion was made and seconded to grant the license free and clear. Barai/Mueller 5-0-0.

3. Lakai Enterline, D.O. – Failure to Disclose

Enterline failed to disclose an arrest for possession of marijuana and furnishing alcohol to a minor. Both cases are older. Enterline recently joined an orthopedic group in Fort Wayne, Indiana. A motion was made and seconded to grant the license free and clear. Strobel/Masten 5-0-0

4. Ronald Mchose, D.O. – Failure to Disclose

It was determined that Mchose did not need to appear.

5. Lindsay Agolia, M.D. – Positive Response – need to be rescheduled

Agolia was unable to appear and will be rescheduled.

6. Robert Holloway, M.D. – Positive Response

Holloway appeared for positive responses on his application. Holloway was dismissed for multiple residency programs. He completed a family practice residency in 2007. He had five (5) OWIs between Illinois (IL) and Missouri (MO). He also prescribed without the proper license and surrendered his MO license. His IL license was then revoked, followed by his Kansas license. Holloway entered a recovery program in Florida and successfully graduated. — successfully graduated. He relapsed in 2017. He is currently involved in a five-year agreement with the MO Health Professions Program. Holloway also disclosed that he was involved in a lawsuit based on a trigger point injection(s). Holloway reported that he has not fully practiced since 2016. He wants to work in an urgent care setting. The Board had several concerns (actions in other states, lack of recent practice, substance abuse evaluation) and wanted him to be evaluated by CPEP and ISMA PAP. Holloway ultimately withdrew his application at his appearance.

7. Nicholas Wetjen, M.D. – Positive Response

Wetjen appeared for a positive response on his application. He has three OWI convictions. In the fall of 2000, he went through treatment for alcoholism through the Minnesota monitoring program. Wetjen relapsed in 2012 and 2017, at which time he entered another treatment program. His other state licenses have expired, and he has moved to Indiana for locums work. He is

currently monitored by ISMA PAP and is in full compliance. A motion was made and seconded to grant license. Barai/Mueller 5-0-0

B. Renewal/Reinstatement

1. Bernard Rerri, M.D. - 01078105A – Renewal PR

Rerri appeared with his counsel, Derek Peterson, for a positive response on his renewal application. The positive response was due to him withdrawing a past renewal application due to a medical malpractice case that has since been resolved. A motion was made and seconded to renew the license free and clear. Barai/McCann 5-0-0.

2. Kenneth DeVoe, M.D. - 01015225A – Reinstatement

DeVoe failed to appear for a second time. a motion was made and seconded to deny the reinstatement for failing to appear. Masten/Barai 5-0-0
