## State Epidemiologist - Access to INSPECT Data:

Pam Pontones, Deputy State Epidemiologist appeared regarding this matter.

Effective July 1, 2017 the following was amended by Legislature to add number eleven (11).

IC 35-48-7-11.1(d) Except as provided in subsections (e) and (f), the board may release confidential information described in subsection (a) to the following persons:

(11) The state epidemiologist.

Ms. Pontones indicated it would benefit the State Epidemiologist Office to have access to identified data to better understand overdoses. They would use it to look at prescribing practices, overdoses, and fatalities from overdoses.

They would like to use in in their violent death reporting system – putting the data into this module would show the areas where overdoses are the highest. It would also show prescribing practices in those areas.

When looking at high prescribing is taking place, they will review both the prescriber and the area in which it took place.

After discussion, the Board agreed to set-up an INSPECT account for the state epidemiologist and delegates.

# <u>Dennis Watson, Assistant Professor, Department of Social & Behavorial Sciences, IU, Richard Fairbanks School of Public Health:</u>

Mr. Watson is requesting a letter of support from INSPECT regarding the following.

A number of barriers within the state prevent people living with opioid use disorder from accessing medication assisted treatment (MAT). Planned Outreach, Intervention, Naloxone, and Treatment (POINT) is an emergency department based intervention that engages individuals revived from an opioid overdose and works with them to overcome barriers to accessing and continuing MAT.

POINT was developed and is currently operating in Indianapolis's Eskenazi Hospital. Initial results of a quality improvement study support the intervention's potential for improving patient outcomes. The proposed project will extend this work using a hybrid effectiveness-implementation study to (a): test POINT's ability to engage patients experiencing non-fatal overdose and reduce opioid mortality and its effect on subsequent outcomes, while also (b): documenting processes and outcomes necessary to assess its potential for adoption and implementation in other hospitals and health systems. The ultimate goal of this work is the development of an effective and scalable intervention for engaging opioid overdose survivors in MAT.

#### The aims of the study are:

- Replicate POINT in another Indianapolis-based hospital to prepare for subsequent effectiveness trial
  - 1a. Test the feasibility of a multifaceted POINT implementation strategy using qualitative data collected through site visit field notes and pone interviews with POINT staff and supervisors
  - 1b. Conduct a pilot test of POINT to establish feasibility of research protocols for a subsequent multi-site trial.
- 2. Conduct a pragmatic cluster randomized clinical trial to establish POINT's effectiveness in comparison to standard care.
  - 2a. Access POINT's effectiveness for improving outcomes utilizing existing administrative and public data
  - 2b. Further test the conceptual model/theory of change underlying POINT through collection of original data among a subset of POINT participants to enhance understanding the mechanisms through which the intervention improved outcomes.
- 3. Determine the extent to which POINT is scalable to other hospitals and systems.
  3a. Conduct an analysis to understand the benefits of POINT relative to its costs
  3b. Indentify potential barriers and facilitators to inform future scaling activities for POINT through qualitative interviews with potential adopters.

This project is strongly aligned with Indiana's 21<sup>st</sup> Century Cures Act funding, as Goal 4 of the state's Cures Act application seeks to develop the Indiana Recovery and Peer Support Initiative, which will implement ED-based peer supports in various hospitals across the state.

Mr. Watson indicated they will follow the patient for a period of one (1) year.

He further indicated that their servers are all HIPPA compliant and they will not share the data. The data will be destroyed at the end of the study.

Mr. Cohen is requesting aggregated, de-identified data on prescribing of opioids and medications used to treat opioid use disorder for use in the Foundation's Dashboard, which the Foundation uses to guide its grant making and more effectively help address the opioid epidemic in Marion County.

To track progress toward goals related to opioid use, the Foundation has created a Dashboard. In addition to outcomes like overdose death rate and non-fatal Emergency Department visits for opioids rate, the Dashboard will track metrics related to access to treatment for opioid use disorder, prescribing of opioids, size of the mental and behavioral health workforce and other topics. Tracking these metrics help guide our grant making by identifying areas of greatest need.

The Foundation is requesting the total quantity of each controlled substance summed up at the patient zip code-month-NDC level. Because data will be aggregated at the drug, month and zip code level, it will not be possible to identify individuals.

Time period is January 2012 through March 2017 with the possibility of adding additional months as they become available

The Foundation will use this information to track number of prescriptions for opioids and prescriptions for medications used to treat opioid use disorder in Marion County each month.

The Foundation will be partnering with IU to obtain an IRB.

The Board voted to approve the request pending receipt of the IRB.

#### Study Purpose – over a three (3) year period:

- Examine data for evidence of changes in prescribing/dispensing trends of controlled medications after implementation of new legislation
- Examine practitioner utilization of the INSPECT System during the same period of time.
- Explore associations across prescribing changes, INSPECT utilization, and overdose incident across geographic areas.

#### Years of Interest:

- Requesting data from 2014, 2015 and 2016
- Years where legislative changes took place federally and in Indiana that involve controlled substances, the prescribing of controlled substances of INSPECT.

In addition, the documents allege, the gang threatened violence against anyone who talked to police and demanded they uphold the "code of silence".

The definition of distribution includes both passage of title or possession. As such, they would be required to have licensure.

If a virtual manufacturer is FDA approved then no licensure is required in Indiana. If it is not FDA approved and they are passing title into or within Indiana, they would need a wholesale drug distributor license and have VAWD accreditation.

Virtual distributors will also be required to obtain a wholesaler license.
