Dr. Wood appeared telephonically and was not represented by counsel regarding a positive response on his initial application.

He was convicted of seventeen (17) counts of Health Care Fraud – Aiding and Abetting in Kentucky. He was sentenced to twenty-one (21) months in Federal Prison. He indicated he served from March 2018 through August 2019 and was released early for good behavior. He was also issued criminal monetary penalties: Assessment \$1,700.00; Fine \$10,000; Restitution \$3,378.00

He was excluded from Medicare and Medicaid and all Federal health care programs for five (5) years.

His Kentucky medical license was by an Agreed Order placed on Restricted/Limited for an indefinite period with terms and conditions. He also has an MOU with DEA.

After discussion, the Board moved to APPROVE Dr. Wood's license on INDEFINITE PROBATION which may not be lifted until his Kentucky license and DEA have been fully reinstated with terms and conditions.

Ibrahim Sadek, M.D., Initial Application:

During his residency he was placed on probation due to "slow milestones". He failed to report this on his lowa application in 2018 and was given a letter of warning.

Again, on his Indiana application he answered the question incorrectly.

He apologized to the Board for answering it incorrectly.

Emad Kowatli, M.D., License #01056842A Reinstatement Renewal:

Dr. Kowatli appeared telephonically and was not represented by counsel regarding his

initial application.

Dr. Kowatli appeared before the Board in July 2020 and presented the following information:

He is currently practicing in Dubai India. He last practiced in the United States thirteen (13) years ago.

In 1998, the Russell County Medical Center revoked his clinical privileges for unprofessional conduct. This was based upon four (4) issues, changing of orders when called in as a consultant without discussing the patient's care with the attending physician; going beyond the scope of requested consultation; refusing to utilize the Hospital's blood transfusion consent form and refusing to disclose the risk of transmission of HIV to patients having a blood transfusion; failing to obtain appropriate informed consent for a procedure; and making abusive and threating comments to Hospital employees.

In May 2005, the West Virginia Medical Board initiated a complaint against Dr. Kowatli, based upon his entering a guilty plea to two (2) misdemeanors in court. In addition, Dr. Kowatli made a misrepresentation in connection with the same on his WV renewal application.

He entered a consent order with the West Virginia Medical Board. The consent order included a public Reprimand for unprofessional and unethical conduct relating to his guilty plea to the misdemeanors of driving left of center and obstructing an officer and falsifying his license renewal.

In May 2006, the Illinois Medical Board placed Dr. Kowatli's license on refuse to renew indefinitely based upon the West Virginia action.

After discussion, the Board TABLED this matter for additional information. The Board requests the following:

- Letter from his current Hospital that they are JCH accredited and comments regarding Dr. Kowatli's skill set
- Evidence of his board certification
- His medical directors credential

At this time, he submitted the above additional documentation for the Board to review.

Dr. Ahmad appeared telephonically and was not represented by counsel regarding his initial application.

Dr. Ahmad appeared before the Board in May 2020 and presented the following

information:

In June 2016, the Arkansas Board found Dr. Ahmad violated the practice act and ordered him to obtain continuing education in boundaries, prescribing and record keeping. They also stated they would do a random audit on his patient files.

December 2013, the Arkansas Board issued an Emergency Order of Suspension on Dr. Ahmad's license.

February 2015, the Arkansas Board order him to pay \$20,000 in hearing costs and to submit to a random audit of 10 charts within one (1) year. In July 2015, he fulfilled these requirements and his license was returned to active status.

June 2016, Dr. Ahmad surrendered his DEA in Arkansas.

October 2016, the Arkansas Board voted that Dr. Ahmad violated the medical practice act and revoked his license.

November 2013, Dr. Ahmad submitted an initial application to obtain an Alaska medical license. He presented that he was under investigation by Arkansas for allegedly violating the medical prescriptive practice regulations. Alaska determined to issue a consent agreement with a fine and reprimand and ordered monitoring to assure he complied with the Arkansas order.

May 2016, the Alaska issued a Summary Suspension citing allegations he failed to properly assess his patients.

August 2016, the Alaska Board accepted the surrender in lieu of revocation after the Board found that Dr. Ahmad posed a clear and immediate danger to the public health and safety if he continued to practice. They accepted this due to his professional incompetence, gross negligence, repeated negligent conduct and unprofessional conduct, opioid prescribing practices including overprescribing high dose opioids, failing to provided adequate patient assessment and obtain patient background information, failing to provide sufficient monitoring and failing to maintain complete patient records.

December 2018, the Arkansas Board denied his request to reapply for licensure.

After discussion, Dr. Ahmad requested to WITHDRAW his initial application, which the Board approved.

Nothing has changed since his appearance in May, therefore the Board APPROVED Dr. Ahmad's request to WITHDRAW his application for renewal.

Megan explained that most fellowships in Otolaryngology are not ACGME accredited.

Dr. Abdelmeguid completed a one (1) year fellowship and Indiana University and is a J2 VISA holder. His visa expires June 2021.

Illing, M.D., Chief, Division of Rhinology and Anterior Skull Base Surgery Associate Residency Program Director, Department of Otolaryngology-Head and Neck Surgery, Indiana University School of Medicine. Dr. Illing stated with his extensive research and clinical training, Dr Abdelmeguid has harnessed a unique practice background which will certainly lend itself to comprehensive, high level Otolaryngology care which will primarily be focused in the underserved populations at Eskenazi and downtown Indianapolis hospitals including Riley, Methodist, and University Hospitals. We anticipate he will be an international leader with his research and training, and will be happy to provide updates during his one year fellowship at our institution and possibly in the future should we be lucky enough to recruit him to stay in Indianapolis.

- C. Kwang Sung, M.D., MS, Assistant Professor Division of Laryngology, Resident Program Director, Department of Otolaryngology – Head and Neck Surgery, Stanford University School of Medicine. Dr. Sung stated Dr. Abdelmeguid has been an excellent clinical instructor/fellow with a strong work ethic that will serve him well in his future as an academic laryngologist. I believe Dr. Abdelmeguid has all the assets, personal skills and mindset required to be an excellent laryngologist and would be a welcome member to any otolaryngology department.

Hanna, M.D., Professor and Vice Chair for Clinical Affairs; Department of Head and Neck Surgery, Director of Skull Base Surgery, Medical Director, Head and Neck Surgery, Depart of Neurosurgery, MD Anderson Cancer Center/University of Texas. Dr. Hanna stated Dr. Abdelmeguid has always demonstrated great interest and enthusiasm in the head and neck and skull base surgery field. All of us in the head and neck department at MD Anderson are very impressed by Dr. Abdelmeguid's professionalism, productivity and self-motivation coupled with his pleasant demeanor and astute mind.
