# II. Adoption of the Agenda

A motion was made and seconded to adopt the amended agenda. Masten/McCann 4-0-0.

# III. Personal Appearances

- 1. Vyacheslav Mikheyev, MD CONTINUED
- 2. Vincent Sawma, MD

Dr. Sawma appeared after disclosing multiple positive responses on an initial application. He reported that he is involved with a monitoring program in Ohio. His sobriety date is January 23, 2012. Dr. Sawma has plans to extend his primary care practice into Indiana from Cincinnati, Ohio. A motion was made and seconded to grant he license. Barai/Masten 4-0-0.

# 3. Brandon Daniels

Dr. Daniels did not appear and will need to be rescheduled.

#### 4. James Marcin, DO

Dr. Marcin appeared after disclosing multiple positive responses on an initial application. He reported that he had a misdemeanor conviction that had been resolved and that his employment contract with a previous employer was not renewed. Dr. Marcin reported that he had active, unencumbered licenses in Pennsylvania and North Dakota. He is no longer in monitoring with the Pennsylvania PHP. Dr. Marcin will be doing outpatient locums work in Logansport in pulmonology. A motion was made and seconded to grant the license pending receipt from Indiana's PAP that Dr. Marcin has contacted them and has been staffed with PAP's medical consultant for possible assessment. #### 5. Mohammed Akhlack Hossain Mazumder, MD

Dr. Mazumder appeared after disclosing multiple positive responses on a renewal application. His Indiana medical license expired in 2019. He was subject to a probationary order in Kentucky and is currently on the OIG Exclusion List. Dr. Mazumder withdrew his renewal application until the issues with his license in Kentucky are resolved.

# 6. Rajat Prakash, MD

Dr. Prakash appeared on an initial application with counsel, Elliot Pinkie. He appeared previously before the board in October 2020 and February 2021. Dr. Prakash's license in Illinois is permanently revoked. He has not practiced medicine in about ten years. No vote was needed, and Dr. Prakash abandoned his application.

#### 7. Patrick Bruno, MD

Dr. Bruno appeared after disclosing multiple positive responses on an initial application. In 2011, he began working in Ohio where he developed a problem with alcohol. He gave up his clinical privileges, which triggered an NPDB report. After this, he moved to Missouri and was granted a license on probation. Ohio subsequently put his license on probation and required the probation to be withdrawn in Missouri before it could be withdrawn in Ohio. His only previous issues with alcohol were charges from 1993 and 2003. Dr. Bruno also disclosed a few medical malpractice cases. A motion was made and seconded to grant the license. Strobel/Barai 5-0-0.

# 8. Rita Assi, MD

Dr. Assi appeared on an initial application requesting a waiver of examination requirements. She took and passed the USMLE outside of Indiana's statutory ten-year period. Dr. Assi presented proof that she meets the waiver requirements (employment contract, medically underserved area, and letters of recommendation). She currently holds a training permit in Texas. A motion was made and seconded to grant the waiver and issue the license. Barai/Strobel 5-0-0.

Dr. Moloff's application was reviewed by the Board. The Board determined that he needed to take and pass the USMLE before being eligible for a license in Indiana.
