The Board previously requested staff to check with FSMB to see if they have a listing of approved foreign medical schools. They do not have such a listing.

Since 1992 a person could not take the USMLE unless the school they graduated from was ECFMG accredited. So, if the person took the USMLE it should be considered an approved school.

If the school is ACGME accredited, it should be considered an approved school.

If the school is on our disapproved listing, staff should review the CA website and if the school is approved through one of the following, then the applicant should request a waiver of their medical school and appear before the Board.

 The foreign medical school is listed on the World Federation for Medical Education (WFME) and the Foundation for Advancement of International Medical Education and Research (FAIMER previously IMED/FAIMER) World Directory of Medical Schools joint directory, or the World Directory of Medical Schools or has been approved by the Medical Board of California.
