**INSPECT Report – Kara Slusser, INSPECT Director:**

- Indiana was asked to be one of the 10 states joining the NABP's PMP InterConnect subcommittee on Technical/Standards. Our first meeting took place last month. We will be discussing data and technology standards, as well as needed improvements and possible upgrades to the PMP InterConnect and Gateway solutions.
- VHA facilities throughout Indiana are now able to use the PMP Gateway system for the first time. In preparation for the go-live, we opened a new role in AWARxE named VA Prescriber. As part of our agreement with the VA, their practitioners will register using their VA.gov email addresses and we migrated all existing VA users from various prescriber roles to the designated VA prescriber role.
- INSPECT recently established connections to several additional PMPs. We are now actively sharing data with Louisiana, Alabama, Texas and St. Louis County. The next connection to be made is North Carolina, which should occur before the end of the year.
- INSPECT is requesting CSR funds in the amount of \$850 for two employees to attend the 2021 National Rx Drug Abuse conference. The conference is being held in Nashville, TN, but all sessions will be streamed live and recorded for attendees to review at a later date. Attendees will be given full access to all recorded sessions online.
- INSPECT has an opportunity to make a change to the PMP Clearinghouse. In our current system, we allow two different identifiers for prescribers and dispensers. Our primary identifier is the DEA number, and the failover is the NPI number. We now have the option to add an additional failover, but it will have to be an identifier from a state managed database, such as the professional license database. If we include this additional failover,

we can collect gabapentin dispensation data from animal clinics and pharmacies filling prescriptions from Veterinarians who do not have a DEA number. Veterinarians are prohibited from having an NPI, so the only other identifier that could be used is a professional license number. There is no additional charge to PLA/INSPECT for this change to Clearinghouse. This will require a coordinated effort between Appriss Health and PLA to ensure that professional license numbers are pre-loaded into Clearinghouse for validation purposes.

- PLA has just signed an agreement with the IJIS Institute for the RxCheck connection. The CDC required all grant recipients to have a contract in place by the end of 2020 and will be requiring a connection by April of 2021. Our next steps include drafting a contract with our technology provider, Appriss Health, to build the connection into AWARDx. This development work will be paid for using part of the CDC grant funding provided to PLA. We do not have a timeline for completion at this point, but the CDC has indicated that they will approve applications for a 30-day extension for states that do not feel they can complete the connection by April 2021.
