PUBLIC RULE HEARING

A public hearing was held by the Behavior Analyst Committee for the Medical Licensing Board of Indiana this 14th day of February, 2025, pursuant to Indiana Code 4-22-2. This hearing was convened in Room W064 of the Indiana Government Center South, 402 West Washington Street, Indianapolis, Indiana at 8:00 a.m. local time. This meeting was held in person and via Zoom.

Notice of the hearing was published in the Indiana Register on January 8, 2025, as well as the full text of the proposed rule.

The purpose of this hearing was to hear public comment regarding LSA Document 24-596 concerning fees, fines, and civil penalties that may be imposed by Indiana Behavior Analyst Committee. All those who address the Board were requested to give their names and addresses for the purpose of the record and this hearing. Only those who address their comments to the chair will be recognized. Individual public comments shall be limited to 3 minutes in length. The Board will consider all comments made at this hearing in deciding what action to take on the above-mentioned rule.

Upon adoption by the Board and approval by the Attorney General and Governor, said rules will become effective 30 days after filing with the Indiana Register.

As of the comment deadline of February 7, 2025, there were no written comments received by the Board in advance of this hearing.

The hearing was opened for comments from the public. There were no comments from the public.
