Mr. Mathews stated that a complaint was filed in the matter of Dr. Pefley regarding an improper crown placement. He outlined the facts of the procedure as outlined in the complaint. He called Brittany Ulrey as a witness for the state. Mr. Mathews submitted Exhibits 1-4 for the Board to review. The Board accepted the Exhibits of the consumer complaint, Dr. Pefley's response to the complaint, treatment records for patient M.W., and re-treatment records of M.W. Ms. Ulrey reviewed the records that were obtained, and the timeline of events for the Board. The Board inquired about whether Dr. Pefley communicated that he was retiring from practice. Ms. Ulrey stated that she did not receive any notice from Dr. Pefley that he retired. She stated that the patient communicated to her that Dr. Pefley informed them of his retirement after the patient had tried to follow up about fixing the crown.

The State concluded that they recommend suspension of the license, and if Dr. Pefley requests reinstatement of his license, then the Board can determine any terms and conditions at that time.

The Board directed staff to email Dr. Sun to advise him that he does not qualify for licensure by reciprocity, and to see if would want to pursue dental licensure by examination.

Dr. Sun's application was tabled.

2. Noelle Maier, LDH - LA Application

Ms. Maier submitted an application for an LA permit and requested that the Board review her submitted documentation. The Board noted that the letter from her program does not look professional. They stated that the course content is acceptable, however, they were

unable to determine whether there were any didactic or clinical hours. The Board also noted that she has not completed the required local anesthetic examination.

X. DISCUSSION

A. Compliance Fund Update

D. Rule Making and Proposed Rule Changes – Nicholas Hart, Director of Board Administration

Nicholas Hart, Director of Administration, Indiana Professional Licensing Agency, presented the updated rule making process. He discussed that the new policy was to streamline the rule making process. In order to start the process a subcommittee is created which consists of two board members and other entities that are associated with the profession. They would review and propose rules to the Board for consideration.

Since the Board has completed the rule, it will be reviewed at the April 4, 2025 meeting.

XI. REPORTS

A. Office of the Attorney General

Amy Osborne provided the report to the Board. She discussed the process of restitution if a consumer complaint is filed, and those matters get referred out. She stated that the consumer protection division, and the licensure division does not handle restitution. She also stated that the Board only sees complaints and violations before them if the AG's office can provide evidence. If the AG's office cannot definitively prove the violation, then they do not bring it before the Board due to lack of evidence.

XII. OLD/NEW BUSINESS

Ed Rosembaum, Indiana Dental Association, discussed the House Bill 1031 Dental Matters. He stated that it has passed in the House and is now in the Senate. He indicated that there are still thirteen (13) states that have pending legislation regarding the approval

of the Compact. Once more states have joined the Commission, they can start the process of setting official standards. The Board members expressed concerns on who would be selected as the commissioners for the compact. Mr. Rosenbaum indicated that it will be up to each state to select their commissioner, and that can be either a board member who is licensed, or an administrator. The Board expressed reassurance that the commission was not going to be all administrators.

Ms. Rader, Dental Hygienist Section Chair, stated that she was asked to inquire on behalf of a colleague if there is a pathway for dental licensure. She discussed his credentials and noted that he does not have the required examinations. Ms. Glickman stated that his circumstances are similar to a case previously before the Board, which was voted down. The Board discussed how their statute and rules can negatively impact qualified individuals. Board counsel stated that licensing some individuals and denying others, when on the surface their training appears to be identical, could open the Board up to litigation.

XIII. ADJOURNMENT

There being no further business, and having completed its duties, the meeting of the State Board of Dentistry adjourned at 12:07 p.m. by consensus.
