OLD/NEW BUSINESS

Continuing Education

The Board believes that new graduates should not be required to obtain continuing education for their first year of licensure and 25 hours for the 2nd year of licensure. This would mimic the BOC requirements and avoid confusion going forward.

Board Action: A motion was made to begin the process to change the rule pertaining to the amount of continuing education required for renewal to no hours for the first year of licensure and 25 hours for the second year of licensure.

The Board discussed that the BOC changed their certification expiration date a few years ago. This change has led to the confusion of athletic trainer licensees with license renewals and when the continuing education is required for the license renewal.

Board Action: A motion was made to begin the process to change the statute that would change the athletic trainer license expiration date from December 31 of even numbered years to December 31 of odd numbered years.


