**Section 14. IC 25-5.1-3-4, as amended by p.l.1-2006, section 421, is amended to read as follows [effective July 1, 2015]: sec. 4. (a)subject to IC 25-1-2-6(e), after a three (3) year renewal cycle ending December 31, 2017, a license issued by the**

**board expires on a date established by the agency under IC 25-1-5-4 in each odd-numbered year.**

There will be a notice on the Board's website explaining the change. An email will also be sent to all licensees with current email addresses while letters will be sent to licensees with faulty email addresses or no email addresses.
