VI. Indiana State Nurses Assistance Program

The monthly report was presented by Program Director, Tracy Traut.

VII. Education

1. Ancilla College / Marian University Transfer of Ownership site visit and monthly report – Lori Huffman MSN, RN, and Dorothy Gomez PhD, RN-CNE

Lori Huffman and Dr. Dorothy Gomez, as well as other members of Marian University Leighton School of Nursing leadership, appeared representing the respective programs. The Ancilla College monthly report, as required by the Plan of Correction currently in place, was delivered by Ms. Huffman. Ms. Huffman reports no significant changes regarding faculty or student numbers and 2 graduates remain as outliers waiting to test. Efforts at outreach have been unsuccessful. Board member Dr. Jason King made a motion to accept the report as submitted and Board member Angela Morris seconded. Motion passed 6-0-0.

Education Compliance Officer Toni Herron provided the results of the site visit conducted in April 2021 as required by rule as a pre-requisite for the request to transfer ownership of the Ancilla College nursing program to Marian University Leighton School of Nursing (MULSON). Sister Michele Dvorak, President, Ancilla College reminded the Board that as of July 1, 2021, Ancilla College would no longer exist. Ms. Herron stated that, while there had been noticeable improvements to the program since her last visit there in December 2019, it remained in significant need of additional resources and opportunities for both faculty and students. With the strong program that MULSON provides, and the strong financial base which MULSON enjoys, they are in a good position to provide the resources and opportunities that Ancilla currently lacks due to size and financial restraints. Ancilla had requested the ability to admit another two (2) cohorts of ASN students in the 2021 calendar year. Ms. Herron recommended denying that request, based on the NCLEX results of current graduates. Ms. Herron stated that denying the additional students would help faculty concentrate on the teach out and success

of the remaining students and allow faculty time to get adjusted to the new routines associated with Marian University. Dr. King made a motion to approve the transfer of ownership of the Ancilla College nursing program to the marina University Leighton school of Nursing effective July 1, 2021. Ms. Morris seconded. 6-0-0.

2. Jersey College Document Revision for Initial ASN Accreditation – Melissa Chase MSN, RN

Melissa Chase, Greg Karzhevsky, Steven Litvack and Rachel Birri appeared to represent the program. Ms. Herron reminded the Board that Jersey College had been requested to revise several policies- among them progression and class repeat policy, clarification of practicum time lab v. clinical facility and clarification of the admissions process. The documents were presented in their packets for Board review. Board president Kim Cooper complimented Jersey College on their thorough review of Board concerns as stated in their previous appearance before the Board, and the timely manner in which the revisions were submitted. Ms. Cooper made a motion to accept the revisions as presented and allow the program to admit the first cohort and Board member Jennifer Miller seconded. Motion passed. 6-0-0.

3. Fortis College monthly report – Christopher Bell RN, DNP, EMT-P

Dr. Christopher Bell appeared to represent the program. Board President Cooper asked Dr. Bell to outline some of the things that he has been undertaking since his start in the position at the first of March. He stated that he had begun with a review of general education courses and discovered a mismatch in alignment with nursing core courses later in the program. He met with gen ed faculty to revise expectations and deliverables to improve student preparation for the health assessment course, the first one on the nursing core content. To assess student preparation at the beginning and the end of the program, he is currently teaching the initial health assessment course as well as the Transition class in the final quarter. He has met with faculty and students to communicate and begin to set expectations. Ms. Cooper stated that it was difficult to tell from the faculty meeting minutes provided that there was real communication between faculty and administration occurring and suggested that the meeting minutes be more detailed regarding participation. Ms. Cooper also recommended a review of the products being provided for student review, that perhaps HESI, Kaplan and Hurst were too much for students to absorb. Ms. Herron reminded the board that Fortis was on a Plan of Correction that entailed monthly written and quarterly in person reporting. The next in person report will occur in July. Ms. Morris made a motion to accept the report as presented and Dr. King seconded, Motion passed 6-0-0.

4. Ivy Tech Community College Anderson monthly report – Jennifer Gale MSN, RN

Jennifer Gale, Dr. Jewel Diller and Joyce Hudson appeared on behalf of the program. Ms. Gale submitted the written monthly report as ordered in the Plan of Correction and stated that significant changes had been made to the program for the coming year with the support of campus administration. The decision has been made to omit any fall admissions for 2021 so that more attention can be available for the currently seated students. Next year, they plan to admit only ASN students, no LPN-ASN transition students for the same reason. While this will result in a loss of revenue for the campus, campus administration was supportive to improve student outcomes and provide more faculty support. Ms. Miller made a motion to accept the report and Board member Diane Murphy seconded. Cooper recuses 5-0-0.

X. Personal Appearances

10:30 a.m.

1. Julie Anderson: Anderson did not appear and will be rescheduled.
2. Kyle VanBritson: VanBritson was arrested in July 2018 and charged with Domestic Battery, an A Misdemeanor, resulting from a physical confrontation with his wife. In January 2019, the charge was dismissed with prejudice. VanBritson said he has struggled with depression and alcohol use. He proactively completed an intensive outpatient program, attends regular AA meetings, and has a sponsor. VanBritson admits he still has work to do regarding the underlying traumas that led to his depression and alcohol use. While the Board appreciated the VanBritson's candor, they remain concerned about his well-being. As aggravating factors, the Board cites the VanBritson's minimization of the domestic battery event, and his failure to be forthcoming with the facts. As mitigating factors, the Board cites the VanBritson's self-enrollment in treatment, and placing his family and nursing career ahead of his depression and alcohol use. The Board placed VanBritson on indefinite probation for a period of at least 18 months. He is to be evaluated by ISNAP (including an MMPI-2 or equivalent) and if he is asked to sign an RMA, then his probation will last for the length of the RMA, unless it is shorter than 18 months.

While on probation, VanBritson is to keep the board apprised of his current contact information and his employment information. He is to cause his employer to sign this Board's order and submit the signed copy to the Board. VanBritson is also to have his employer submit quarterly reports. If a candidate for an RMA, he is to comply with its terms. He must also comply with any recommendations of the MMPI-2 or equivalent. Cooper/Murphy 5-0-0

3. Myah Swoveland: Swoveland has failed the NCLEX three times. She is currently completing the Kaplan Review Course. The Board motioned that Swoveland is to complete the Kaplan review course and receive a 95% probability of passing. After that, Swoveland can test one more time before being asked to come before the Board again. Cooper/Morris 5-0-0
4. Tammy Kuhn: Kuhn was terminated from Core Nursing Rehabilitation on July 24, 2020 after a dispute between two residents. Kuhn maintains she does not know why she was fired since she arrived after the dispute. Kuhn believes a CNA complained. Kuhn was previously on probation with th Board after she was arrested for criminal recklessness after an incident at a previous employer. The Board motioned to deny Kuhn's renewal. The aggravating factors included the irregularities in her accounts, her demeanor, rudeness to a Board member at her first personal appearance, and a lack of remorse, insight, and reasonableness of her actions. 5. Michelle Jackson: Jackson's license expired in 2007. She has been licensed in South Carolina since that time. She is moving back to Indiana. Her South Carolina license was on probation until 2016.
