VII. OLD / NEW BUSINESS

1. Report From The Office Of The Attorney General

Derek Peterson provided a report from the Office of Attorney General. He introduced some of his staff to the Commission. There are currently 69 open litigation files, 13 Cease and Desist, Four Summary Suspensions and 351 open consumer complaints under invesitgation. There have been 38 consumer complaints closed. The average age of a consumer complaint is 11.9 months. The open litigation files are over 16.8 months old, but that number should decrease with the ALJ panels.

2. Real Estate Education Advisory Council Report

Cathy Harbaugh reported to the Commission the REAC Report and provided information about the classes that were approved, denied or tabled.

Cathy Harbaugh also mentioned some PSI proctored test issues. There is no way to contact anyone if issues arise. Internet Connectivity seems to be an issue and plays a major role in the problem.

John Briscoe asked about the passing rate of the exam rate on the first time. The average passing is 50% to 65%.

3. Seller's Disclosure

Pam Lumley presented the Kentucky Reciprocity Agreement and the proposed changes in this proposed agreement. There was discussion about how long they would need to be licensed in their jurisdiction. Two years of licensure is what is recommended and the common standard. There were other modifications discussed. James Harry requested feeback from the Commission.

Paul Boyter made a motion and was seconded by Charlie Shook to approve the Kentucky Reciprocity Agreements with the recommended modifications and to send a draft of the agreement Kentucky for review.

2. Property Management Licensing – Jim Litten

Anne Johnson fro IAR has suggested to reach out to their membership to educate them about property management.

There is a growing problem of unlicensed property management.

The Office of the Attorney General's Advisory Opinion Division has not been asked for an opinion on this matter and will likely decline to give one if asked. This is not an issue of a gray area in the law but rather an issue of lack of information and understanding by licenses. The Commission will take up IAR's offer to help educate its members on the issue.

3. **Illinois reached out to Indiana about reciprocity**. Paul Boyter will join with James Harry and Amy Hall in a conversation with Illinois.

4. Other Issues

There may be a few more hearings at the full IREC meetings in the future so that the Commission is not using staff and PLA resources for 3 meetings a month. Discussion about Sharepoint and the problems the Commissioners experienced accessing it. A few of the Commissioners didn't feel Sharepoint was user friendly and most utilized the the Zip file. Though there was a request to let the Commission know when the full packet was ready to view on Sharepointe.
