Timelines on rulings: a lot of states do not however we do.

Good moral character: Keep the definition vague and judge each case separately.

Suggested attend other board meetings to see what other boards are doing with their litigation (such as medical, nursing)

Some states require the state exam as part of their disciplinary action. James Harry research if the board can require passing the exam as part of a litigation case.
