**II. ADOPTION OF THE AGENDA**

Cooper/Smith move to adopt agenda. Agenda adopted, 8-0-0.

**III. ADOPTION OF THE MINUTES FROM THE JUNE 18, 2015 MEETING OF THE BOARD**

Cooper/Smith move to adopt minutes. Minutes adopted, 3-0-5. The Board has four new members and one experienced member who was not present for the June meeting and therefore they abstained on this matter. (\*\*\*\*\*place attorney waiver in the notes\*\*\*\*\*)

**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist, Director of ISNAP gave the report. Agreement with Parkdale has been approved by Indiana Professional Licensing Agency, ISNAP has also negotiated cheaper drug urine screening tests with its provider. He also discussed INSPECT reports and that he is seeing more compliance with those who are in the ISNAP program as "non-regulatory" participants. Mr. Lindquist then addressed the students in attendance regarding the mission and duties of his program.

**V. EDUCATION**

**A. St. Elizabeth School of Nursing Site Visit Report (Deacon John Jezierski)**

Deacon Jezierski was joined by Dr. Michelle Gerrety on behalf of the school. This is a repeat site visit after a visit for low NCLEX scores one year ago. Ms. Toni Herron, Education Compliance Officer, reports TEAS testing has been added as an admission requirement. Positive factors for the program include stable number of faculty and a good relationship with community partners which results in a wide variety of clinical opportunities. While functional, the physical facilities are dated and in need of upgrade. Instead of building a new building, the program will be relocating to an existing part of Franciscan St. Elizabeth Hospital which is no longer in use. The move will bring all health related programs together in one location.

Ms. Herron's recommendations are modified to include:

Suspend monthly written reports while NCLEX scores remain >80%.

Provide quarterly written reports to the Board to track progress – next report due in October 2015. Next in person appearance before the Board in February 2016 to address 2015 annual NCLEX rates Hall/Smith, 8-0-0 motion carries .

**B. St. Elizabeth School of Nursing Request for Curriculum Change (Deacon John Jezierski, Dr. Michelle Gerrety)**

The proposed curriculum change would be effective for the fall of 2016.  
Hall/Cooper, motion carries 8-0-0. Curriculum change accepted.

**C. St. Elizabeth School of Nursing Monthly Report**

**D. Chamberlain College BSN Request for Curriculum Change (Margaret Harvey, Diane Smith-Levine)**

Dr. Harvey and Ms Smith-Levine submitted a curriculum revision request—they are re-defining 7 credits and would slightly reduce clinical hours. Cooper/Presley, request is accepted 8-0-0.

**E. Fortis College Site Visit Report (Kathryn Plankenhorn, Dr. James Cox)**

Katheryn Plankenhorn, Laura Darnell and Dr. James Cox appeared on behalf of the program. This is a repeat site visit subsequent to the site visit in May 2014 due to low NCLEX scores. There was a Plan of Correction submitted and accepted in August 2014. Education Affiliates is the corporate parent of this program. They earned ACEN accreditation in 2014. Subsequent to the previous site visit, the Board voted to approve the LPN-RN bridge program. Since the last site visit, Ms. Plankenhorn is now only responsible for nursing. The campus president is very active and supportive of the program. He meets with incoming students to discuss the program before they attend. Many of the students are foreign born. Fortis has an intense program called Quarter 9, to help students with NCLEX and tailors it to their strengths and weaknesses. There is strong leadership with strong campus support. However, acute care sites are a concern. The clinical coordinator spot is open. NCLEX scores have shown no improvement. Ms. Hall is worried about student/instructor ratio. Ms. Hall is concerned with low 2<sup>nd</sup> quarter pass rates which are at 66%.

Final recommendations are:

Remain on initial accreditation until repeat site visit in one year

Submit new Plan of Correction addressing declining NCLEX scores

Quarterly in person reports to the advise Board on progress with Plan of Correction – to begin October 2015

Hall/Cooper, 8-0-0 to accept Ms. Herron's recommendations.

**F. Fortis College Notice of Financial Restructuring**

There will be no change of ownership in this school. Hence, no vote is needed.

**G. ITT Indianapolis Monthly Report (Alice Marie Holder)**

**H. ITT Indianapolis Site Visit Report (Alice Marie Holder)**

Ms. Holder and Mariah Wood, who is from the national office of ITT, appeared representing ITT Indianapolis. This was a repeat site visit after the Spring 2014 visit for low NCLEX scores. Ms. Herron states the program has significantly improved within the last year. There is now a better admissions system and nursing students are given adequate instruction on what will be expected of them. There is now more local control and faculty stability at the school. Students stated that didactic schedules come to them on time but that there is still issue with clinical schedules being appropriately disseminated in a timely manner. There are still concerns that too much of the curriculum comes from the national office and not from the local campus. Ms. Holder states that concerns with computerized testing voiced by students have been addressed with the addition of an IT person on the campus who can remedy the problem in real time. Ms. Cooper is worried about supplies at the school. Ms. Hall congratulates the staff for the recent success of their students passing the NCLEX. Ms. Hall would like more coordination for the scheduling of clinical rotations.

Final recommendations are:

Remain on conditional accreditation for remainder of 2015

Admissions are suspended until NCLEX scores >80% for four consecutive quarters

Submit new Plan of Correction

Monthly written reports, quarterly in person visits to Board and quarterly student surveys to update progress beginning in October 2015.

Motion to accept Ms. Herron's recommendations, Hall/Cooper, 8-0-0.

**I. ITT South Bend Monthly Report (Linda Newton)**

Ms. Cooper is worried about continued struggle with NCLEX students. Second quarter pass rates are 75% which is a great improvement but it is a small sample size. Ms. Newton states that they have implemented Kaplan review for their students for the NCLEX. Monthly report was accepted.

**J. ITT Merrillville Monthly Report (Kimberly McIntyre Borum)**

Ms. Borum, Ruth Clayman and Mariah Wood appeared on behalf of Merrillville ITT. The preliminary NCLEX pass rate for 2015 Quarter 2 was 56%. The monthly report was accepted.

**K. MJS Monthly Report (Annette Murray)**

Ms. Murray represented MJS. There is a concern that many of their graduates are not taking the exam so it is difficult to retrieve NCLEX scores from them. Report is accepted.

**L. MJS Curriculum Revision Request (Annette Murray)**

Ms. Murray has requested to change the Pharmacology class from one 3 credit course to four 1 credit classes. The one credit classes would be spread out and coincide with the specific course being taught, i.e. cardiac medications would be taught with cardiac content, pediatric and obstetric medications would be taught with peds & OB content, etc. Ms. Cooper believes these 1 hour courses would water down the educational product. Ms. Hall motions to accept, Pressley seconds it passes 7-1-0 (Cooper votes no).

**M. St. Elizabeth School of Nursing (Deacon John Jezierski)- EEOC Complaint**

Deacon Jezierski reported that a student has filed a complaint with the EEOC on the basis of racial discrimination. The school is investigating the complaint and will advise the Board of any further developments or findings. No vote required.

**VI. DISCUSSION**

**1. Education Annual Report**

**a. Addition of Bridge Programs to Program Type- LPN-RN, RN-BSN**

Toni Herron has requested that the Board consider revision of the Annual Report submitted each fall by every pre-licensure nursing education program in Indiana. The current format does not ask for information regarding on-line or bridge programs. This makes it difficult to know the number and types of programs available in the State to advise consumers. Ms. Herron requests the addition of categories for distance and bridge programs to the Annual Report. Hall/ Smith 8-0-0.

**b. Add Question Regarding Distance Education:**

**i. Do you have a pre-licensure distance program?**

**ii. Please list all host states where your distance students reside.**

Ms. Herron states NCSBN has asked states to add the above listed questions to their Annual Report to aid in tracking distance education for pre-licensure programs. Hall/ Smith 8-0-0.

Ms. Johnson-Brooks appeared for her personal appearance regarding her application for licensure. She answered yes to number 3 on her application. In 2010, she used a bank card she was not authorized to use. She found a bank card lying on the ground and used it. Turns out the bank card she found belonged to a patient at the facility she worked at. She did not know it belonged to a resident. She successfully completed her criminal probation. She answered yes to number 1 on her application. She had a CNA license at the time of her arrest and lost it due to the criminal matter. She answered yes to question number 4 on her application. She was terminated as a CNA due to the criminal matter. She has not had any other issues. She graduated in 2007. She last tested in April 2010. She has purchased the 2014 version of the NCLEX and flash cards, and she answers questions online daily.  
Ms. Presley recommends the following: She must complete a refresher course with a clinical component. Once she submits documentation showing this has been completed she will be allowed to test and her license is to be issued free and clear.

Ms. Gates appeared for her personal appearance regarding her application for licensure. She answered yes to number 3 on her application. In December 2014, she received an OWI. She was pulled over after leaving a Christmas party. Her blood alcohol level was 0.9. She is currently on unsupervised probation. It will be finished next month. She has had no other issues.  
Ms. Presley recommends the following: She is allowed to test. She must have an ISNAP evaluation. She was an LPN license with Kentucky and Indiana. Her sobriety date is May 4, 2011. She did not put this on her LPN renewal. She has not had any issues since Florida.

Her blood alcohol level was .08. She has completed the criminal probation. She no longer drinks. She graduated in 2008 and has tested twice.

Ms. Jennings appeared for her personal appearance regarding her application for licensure. She answered yes to question number 3 on her application. In December 2014 she was charged with welfare fraud. They said she didn't turn in some information. She did turn the information. It was a felony but dropped to misdemeanor. She has to pay \$2100 for what she took in food stamps. When she was 18 she had a shoplifting charge and later the year she got into a fight. She has a CNA but doesn't use it; it was never been in trouble.




