OLD/NEW BUSINESS

NCEES Resolutions/Voting Delegate

The board discussed the resolutions that will be voted on at the NCEES Annual Meeting in Washington, D.C. NCEES Education Committee is presenting a motion to accept a technology degree for Engineering Licensure. It was discussed. The Indiana Board reviews the courses taken with all applicants, which allows much holds applicants to meet the existing Rules on Education, which keeps the level of proficiency relatively high. The credit hours required by Indiana Rules for licensure are relatively light in comparison to those of EAC accredited engineering programs, but are more stringent than educational requirements of ETAC accredited technology programs.

Separate structural exam applicant to be introduced as a new license status. There is also a press for licensing per professional engineer specialty – civil, electrical.... This will be another hot topic at the NCEES meeting. Decoupling was discussed again, as it is becoming a buzz word within NCEES culture.

Comity applicants are not equal from state to state. There is much scrutiny and review in some states versus almost none in other states for comity licensure applicants.

Steve Gillman was determined to be the voting delegate for the engineer board.

INTERIM REPORT OF THE FE EXAM TASK FORCE

Vince Drnevich reported that the associate dean at Purdue is very earnest about following through with the previous associate dean's commitment to emphasize taking the FE Exam. He will work toward becoming licensed as a PE because he is not currently licensed. Most engineer professors are not licensed PEs.

Amy Barrett of INSPE, will be providing some talks in Evansville about the importance of the FE.

Inquiries were made about the three vacant spots on the board and if there was any movement toward filling them. No actions were reported.

INDUSTRIAL EXEMPTIONS –US Legislators are deliberating on a new law to remove exemption for engineering licensure for those involved in designing gas distribution pipelines. This is response to the explosion that took place in the Merrimack Valley, Massachusetts last September. Indiana requires these people to be licensed and has no exemptions for state and federal employees.
