Written and verbal report provided.

Human Trafficking: The OAG is working with US Attorney General and Homeland Security to identify human trafficking, possibly provide Licensee training, train OAG staff, and involve local law enforcement. They can send the Board the information to get distribute to licensees to show them what to look for to identify possible victims. They also offered to work with our inspectors to train them as well.

CORRESPONDENCE FROM THE COMPLIANCE DIVISION

Zaneta Nunnally, Director of Compliance, provided the board with the compliance inspection procedures to explain the difference between a corrective action plan and a failed inspection and the Opportunity to Correct statute that supports their inspection procedures.

Razor blades are not permitted while performing manicuring services, however the skin grater/file type device is not considered a razor blade.

OAG Advisory DAG indicated that a salon that offers only esthetic services does not have to have a separate room. The salon must have all equipment indicated in the rules regardless of the services they are providing.

Coloring lashes, or any other hair on the body, requires a cosmetologist license.
