**V. Education**

1. Indiana University Southeast curriculum revision request for substantive change – Julia Mattingly DNP, RN

Dr. Julia Mattingly appeared on behalf of the program. Education Compliance Officer Toni Herron stated that IU SE is appearing for approval for a substantive change in their curriculum for the BSN at IUSE. Last curricular revision was ten (10) years ago. The curricular change would begin in the Fall of 2025 for general education courses and Fall 2026 for nursing courses. Major objectives of the substantive change include:

- Course resequencing – electives moved further back in the curriculum and physiology and microbiology moves up in curriculum.
- Elimination of summer course requirement( Health and Wellness) with content distributed across three (3) core courses
- Credit hour adjustments ( Data Analysis for Nurses removed from curriculum)
- Addition of pathopharmacology course two (2) semesters
- Skills lab & practica credits refined
  - Skills Labs: reduced from 4 to 2 credits.
  - Practica : increased from 19 to 20 credits.
  - *Capstone* expanded from 3 to 4 credits.

- Added a sophomore-level *Foundations of Nursing Practicum* (1 credit) to initiate early clinical engagement.  
Current admissions are annually in the fall with a total of 56 students.

After discussion, the Board voted to approve the substantive change as requested.

Ms. Roach and Dr. Kim Wiegand appeared on behalf of the program. Ms. Herron stated that the construction site visit completed the two-phase renovation of space to accommodate moving the nursing program into the main campus Ferguson Building from the separate Lee Marchant School of Nursing across the street. Ms. Herron noted the extremely effective planning and communication between the facilities and nursing personnel. This creates separation of skills and simulation labs. After discussion, the Board voted to approve immediate occupancy and use. Ms. Cooper recused. Ms. Miller joins online. Morris/Magers 6-0-0.
