### VI. Education

1. Trine University construction site visit – Angel Jennings PhD, RN

Dr. Angel Jennings and Elaine Cooper appeared on behalf of the program. Education Compliance Officer Toni Herron stated that Trine University (TU), located in Angola, was before the Board for approval for occupancy and use of newly constructed simulation and skills labs made possible by partnering with Cameron Memorial Community Hospital (CMCH). Ms. Herron stated that TU had been extremely collaborative in working with community partners to fund the new space.

Board member Kim Cooper asked about ongoing funding for the new space, as well as the consideration of artificial intelligence (AI) and virtual reality (VR) for use in the new space. Dr. Jennings stated that the funding was through CMCH education budget. Ms. Kim Cooper stated that it was recommended to consider adding simulation to the TU Nursing budget as a line item. AI and VR are technologies that are being considered for the future after more research. Ms. Cooper made a motion to approve occupancy and use and Board member Dr. Emily Sego seconded. Motion carries 8-0-0 (Cooper/Sego).

2. Ivy Tech Kokomo/Logansport construction site visit report - Kimberly Wiegand DNP, RN, CNE

Dr. Crystal Lawson and Dr. Kimberly Weigand appeared on behalf of the program. Ms. Herron stated that the Ivy Tech Community College (ITCC) Logansport campus is a satellite of the Kokomo campus. Increased enrollment at the Logansport campus because of several factors required additional space for skills and simulation labs. Ms. Herron stated that ITCC-L created that increased space by repurposing classrooms that were not previously fully utilized. The only concern identified during the visit was the simulation "control room" was a table behind a curtain in a corner of the space. Dr. Wiegand stated that changes were underway to remedy that concern. Board member Dr. Jason King made a motion to approve immediate occupancy and use of the space and Board member Rena Magers seconded. Motion carries 6-0-0. (Cooper recuses.)

- 2. Crystal Rene Marquez- Crystal is appearing for the RN by examination application. Crystal was previously revoked on September 12, 2017. The license was previously revoked due to charges of sexual misconduct with a minor. Crystal was initially licensed in 2007 as an RN. The RN license was summarily suspended in 2015 until it was revoked in 2017. Sexual misconduct with a minor who was a 15-year-old boy and boyfriend of the teenage daughter. The mother of the victim turned the nurse in. The boy was using a cell phone and that is how she was found out. A plea deal was made, and the charge was lowered. Nurse states that she did therapy right away. ALJ asked about therapy and the theapy was her friend. No medical records for teherapy. Went bankrupt. Lost her kids. Lost her marriage. Lost a baby during that time. Has an MBA in healthcare. She completed a refresher course with Sigma. Prior to all this, the nurse worked in a nursing home. Has never received a psychological evaluation. Met a friend/preacher that "counsels" her. Has never been treated for anxiety. Was given anxiety medicine for about one month in 2016. The licensee did submit over paperwork showing the sexual misconduct charge was expunged. The nurse knew at the time that what she was doing was wrong. That the mother of the victim would not want her son having a cell phone or having relation with the nurse. Licensee states she went with a minor because she did not feel good about herself. Blames others and states because of how they treated her the way they did she did what she did. Recommendation to take an NCLEX review course, Take the NCLEX test again, Refresher course with clinical unless Toni Herron, Education Compliance Educator, will take Sigma if Toni Herron does not take Sigma the nurse will need to do the Ivy Tech Refresher Course with Clinical Component. MMPI 2 or equivalent. Must come from a licensed care professional that is licensed by the state of Indiana and follow recommendations and treatment plan sent to IPLA. Can not be her current primary care provider or current licensed therapist that gives her the MMPI 2. We will need these results before Crystal is allowed to work. Probation for a length of 24 months of active practice. Sign board orders, quarterly reports, updated demographics/criminal matters/workplace discipline. Limitations in practice. Can not work with children and anyone under 18. Can not work in home care. Must have onsite supervision. Aggravating factors –Stated she was in therapy when she is not in consistent therapy because there are no consistent records of this therapy, not completely transparent about the cell phone the boy had. Licensee could not be clear about her record and what happened, acknowledged that she had absence of satisfaction in her marriage, had surgery and lost weight and that's why she had sexual prolonged relationship with a minor, the licensee did state the boy was almost 16, but the boy was 15, concerns that there is a heinous crime that was committed and was in disclosure mode, the licensee only talked about herself and

how she lost everything, the licensee did not bring up the victims and what the victims lost, licensee is still showing the deficiency's that were in the MMP2 in 2017, Licensee states she has no awareness of how the victims were impacted. She was asked if she received and reviewed the board order. She confirmed and ALJ pointed out the minor did struggle and that made Crystal's previous statement untrue. When asked if it was a deficiency or disease to engage in sexual relations with a 15 year old minor, the initial response was no, acknowledges that she had been educated in mental health and was also educated in pediatrics which would have clearly covered that these behaviors warranted further evaluation. Mitigating Factors – Expunged Matter

- 3. Tamika Kakisha Nelson- Tamika Nakisha Nelson is appearing for the examination LPN application. Tamika graduated over 10 years ago from ATS Institute of Technology. Tamika has never passed the NCLEX examination before. Previously had a PA in 2017. In that PA it was stated that Tamika had previously taken the NCLEX 3 times. The PA was also over nondisclosure of an endangerment of child charge. It was recommended to issue on probation once Tamika passed the examination. The app was abandoned, and Tamika never took it. Graduated from college in 2013. Recommendation to deny and go back to nursing school.
- 4. Lana Paige Lewis- Lana is appearing for the LPN reinstatement application. Lana expired 10/31/2014. Last worked in 2013. Recommendation to do the review course, take the NCLEX, refresher course with clinical component.
- 5. Shanta White- Shanta is appearing for an LPN by endorsement application for answering yes to #1. Shanta has a previous charge of attempted murder/aggravated battery- discharge of firearm from 2018. Attempted murder/intent to kill/aggravated battery discharge firearm. The charge happened in IL. Not Guilty was the final outcome. Shanta was also arrested as a minor for a fight, but the charges were dropped. Currently working in IL as a nurse. Recommendation to issue the license free and clear. Mitigating Factors Currently employed, no workplace discipline, the matter has been managed through the courts of IL, listed as Not guilty

Vontasia is currently on probation for an OWI and still fulfilling probation requirements. Someone called the police on Vontasia. Vontasia was chasing after her ex. The blood alcohol was over .08. She is on probation until AUG of 25. The licensee is very transparent and understands that what she did was very wrong. That she could have hurt herself, her boyfriend and/or a random person. Recommendation to let her test. Issue the nursing license onto probation. Probation for a length of 9 months or the length of criminal probation whichever is the longest. The 9 months must be spent in active practice. Signed board orders, quarterly reports, update demographics/discipline.

- 10. Chassidy Rene Harper-Chassidy is appearing for LPN by examination application. Chassidy has previously passed the LPN examination and has been revoked. Chassidy graduated from Brown Mackie in 2008 and was issued an LPN license in 2009. This LPN license was then revoked in 2014. It has been over 10 years since last practicing as a nurse. Chassidy appeared in 2022 and was allowed to take the test again after a refresher with clinical component. Chassidy did complete the refresher with clinical component. Chassidy retested and failed the examination in 2023. NCLEX review course with predictor score with either ATI/Kaplan of 95% or greenlight and be allowed to test. Once she passes the examination, the license would be issued onto probation for a period of 18 months with 12 months of active practice. Signed boards from herself and employer, quarterly reports, updated demographics/workplace discipline/any legal matters. Aggravating factors Past history with the board, unsuccessful attempts with ISNAP,

unsuccessful attempt on probation, unsuccessful suspension, nurse knowingly worked despite being suspended and was revoked. Mitigating Factor – ISNAP present/ reviewed her case log and stated that at the time there was positive marijuana finding from workplace drug test they could not find any findings for substance abuse disorders as a result this board member is not requesting any further, inquiry into current life habits reports busy taking care of chronically ill child, denies current substance use, abundantly transparent.

- 13. Anthony Colley- Anthony is appearing for the pre-approval licensure application. Anthony uploaded information about two criminal cases. One is from 2006, and the other is from 2013. Arrested a total of 5 times. 2014 is the most recent charge which was Wire Fraud. Sold stolen property on the internet. Generators from China were the products stolen and being sold. The original sentencing was 30 months in prison camp and a \$300,00-dollar restitution. The imprisonment was for 12 months. Then was on probation for two years which is now completed. The restitution is a quarter of the way paid at this time. Roughly \$75,000 paid. Prior to this charge there was another charge in 2014 for invasion of privacy. His ex-wife at the time had gone to another judge and asked for a restraining order to which he was not aware of. These charges were dismissed in divorce court. Domestic Violence charge in 2010 to which the matter was dismissed. 2006 was arrested for forgery. Wrote bad checks and cashed them. Ended up being misdemeanor theft. Also arrested for auto theft and theft in 2005 to which these charges were dropped. Only the wire fraud charge is federal charge. Anthony went to school and graduated from Ivy Tech with an associate degree in software development. Has remarried and had another child. Became the safety director of an international transport company. Has bought a home. Focused on doing the right things and taking care of his family. Was granted full custody of his older children. Spent the last 10 years trying to grow and be a good remodel to his children. His role as a safety director is looking over 2000 drivers that travel between Canada and all the 48 states. He's been with this company for 3 years. Recommendation that the board will issue the license. The license may have potential stipulations. If the felony still stands a compact nursing license can not be issued. Aggravating Factors – Escalating behaviors noted in the background record. Mitigating Factors-Service to country, transparency, a focus that has not let challenging circumstances to deter him.
- 14. Bridgette L. Carroll-Bridgette is appearing for both the RN and APRN reinstatement application. Previously was on Emergency Suspension in 2019. The licensee was charged in 2019. Missing adderall and it went on for about two years. The daughter went to an adult physician, and they asked daughter why she was on adderall because Kasper showed it and then the daughter told her physician she does not use those meds. Completed KARE in OCT 24. Which was a successful completion. No open stipulations and/or restrictions on her license. Bridgette knows what she can practice in and cannot practice in to make her successful. In 2013, she had wrote a prescription for herself for estrogen. Free and clear license in KY. Recommendation to renew the RN and APRN. Mitigating factors transparent, KY is her state of residence since 2002-2003, employed in KY, actively living and working in KY, no immediate plans to relocate, did complete KY KARE program in 2024 with no outstanding stipulations for completion, actively working with any state she has expired/denied licenses to rectify and clear those matters. Recommendation to license free and clear the RN and APRN. Note while IL is her exam state (home) state, expired well before the issue with her KY license thus making them unrelated in this board members opinion.
- 15. Beverly June Bola- Beverly is appearing for the RN by examination application. Beverly graduated from Ivy Tech in 2008. Beverly has never taken and passed the NCLEX RN examination. Recommendation to deny and go back to nursing school.

17. Tonya Morgan – **FULL BOARD.** Morgan appeared with counsel Cynthia Marcus on an LPN renewal application with a positive response. Morgan has a criminal diversion agreement that is still open. This stemmed from a domestic dispute at her home with her daughter. She was arrested at the conclusion of this incident. This is related to a family dispute. Her daughter has a history of drug use and a criminal history. In an unrelated matter, Morgan was also suspended while working at Majestic Care related to some missing fentanyl. She was drug tested and cleared from suspicion. Later, she was terminated from Majestic Care at the same time as a change in management. The incident that resulted in her termination was a communication issue related to a dispute in a patient transfer. Morgan lost her temper and hung up on an RN at the facility that received the patient. She obtained subsequent employment. She was able to provide a letter of reference from a nurse coworker at Majestic Care. Her employer is aware of her criminal case. A motion was made and seconded to renew Morgan's license free and clear. King/Gallegos 7-0-0.
