# 3. NCARB Summit Reports

Todd Scoggins provided a report about the Regional Summit Meeting and introduced Mike Armstrong, Josh Bastin and Roxanne, executives from NCARB, to segway into the report from the Regional Summit and the plans for the future of licensing via various pathways. Roxanne stated her role in expediting and providing excellent customer service for the applicants and the board members. There is a dedicated point of contact with each member board. Her team is aligning with the individual members boards specific needs.

Josh discussed his role in outreach and engagement with member boards and other stakeholders within the industry.

Mike Armstrong discussed the future pathways to licensure. To bring flexibility and various pathways to licensure, which opens licensure up to more individuals. Pathways to Practice will open licensing, showing 16 competencies that should be required for licensure. Reconsidering AXP hours, but fundamentally the current system of reporting hours, education, the exams are being studied and reviewed. Finding the basic framework and adjusting the assessment tools that allow these various pathways to be implemented. The feedback from the jurisdictions is imperative to make this work, with the full assistance of NCARB.
