II. ADOPTION OF THE AGENDA

III. ADOPTION OF THE MINUTES FROM THE JULY 17, 2014 MEETING OF THE BOARD

A motion was made and seconded to adopt the minutes of the July 17, 2014 Board meeting. Ogle/Laux, 8-0-0, motion carries

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Mr. Lindquist appeared on behalf of the Indiana State Nurses Assistance Program ("ISNAP"). He reminded the Board of the ISNAP conference on September 11, 2014. ISNAP is meeting with their vendor to complete their informational video next week and hopes to present the completed product at their conference. ISNAP's quarterly report was presented as well.

V. EDUCATION

A. University of Indianapolis Curriculum Changes (Cheryl Conces and Kathy Hetzler)

Staff appeared from University of Indianapolis. Board members had no questions regarding the request for curriculum change. A motion was made and seconded to accept the curriculum changes. McIntosh/Laux, 8-0-0, motion carries

B. MJS College of Nursing Site Visit Report (Annette Murray)

Education Compliance Officer Toni Herron conducted an unannounced site visit in May 2014 due to a change in their physical location and declining NCLEX scores. The program is a 15 month accelerated ASN degree with fifteen students enrolled. The recommendation is for monthly progress reports beginning in September 2014; updated resources should be included in both resource lab and simulation lab; increased acute care sites; improvement of NCLEX item writing through faculty development and refresher courses. The staff indicated they are still searching for acute care sites as they are difficult to obtain for ASN level programs. Staff expressed no concerns in following the site visit recommendations and they are in the process of obtaining national accreditation with ACICS which will help their clinical site placements. They are accredited by ICOPE. ACICS will be making their first visit in September or October 2014 and a second visit 4-6 months after that. Board members asked about their obstetrics and what the school is working towards. They are seeking approval for the purchase of an OB mannequin and the simulation scenarios for that mannequin. They have a Masters-prepared nurse who runs the simulation lab and runs the simulation scenarios. The staff indicates pre and post-natal clinical is being held at off-site clinics and only delivery clinicals will be in the simulation lab. Board members asked about faculty development in test writing and increasing rigor. Faculty indicated they are attending the NCSBN test writing and development workshop for six weeks. Faculty has not attended national level workshops at this time. Board members encouraged faculty to obtain individual national certification within their areas of expertise. **Board Action: A motion was made and seconded to accept the site visitor's**

recommendations with written monthly reports submitted with changes and updates made and progression of faculty development in the third and fourth quarter of 2014. Narwold/Ogle, 8-0-0, motion carries

C. IU Kokomo BSN Curriculum Changes (Linda Wallace)

Staff appeared from IU Kokomo regarding their curriculum changes. Board members had no questions on the request. **Board Action: A motion was made and seconded to accept the changes. McIntosh/Laux, 7-0-1, motion carries (Narwold abstains)**

E. Medtech College All Campuses Monthly Report

Staff appeared from Medtech College with Myra Selby, Counsel for Medtech, regarding their monthly report. Deborah Horhoro is the new Program Director at the Fort Wayne campus and will begin employment on September 2, 2014. Board members appreciated the faculty education that took place in the months of June and July 2014. Board members indicated there should be more documentation in the faculty minutes that faculty are exchanging information vs. information being brought down from above. Board members see more focus on faculty expectations. The next quarter starts October 6, 2014. Current projection admissions are as follows: Indianapolis- 22 PN and 2 RN students enrolled currently with increased TEAS requirements Indianapolis believes they will have 10-15; Greenwood- 2 RN and 22 PN admissions currently. Unverified NCLEX pass rates are reported by Medtech faculty as follows: Fort Wayne-unknown; Indianapolis ASN 45.76% PN- 91.8%; Greenwood RN-23.88% PN 58.33%. Ms. Cooper strongly cautioned on admitting new students in a small cohorts because if they lose students their NCLEX scores will be easily affected. Medtech has not decided on a minimum amount of students enrolled at this time. Ms. Cooper asked if small cohorts would be taught out if they were small and staff indicated they would. No Board vote was required at this time.

F. ITT Tech Indianapolis Monthly Report (Marie Holder)

Staff appeared from ITT Tech Indianapolis regarding their monthly report. Their current NCLEX scores are 76.9% for the second quarter of 2014 with approximately 13 test takers. Board members asked about clinical sites and they have acquired a physician's office as a clinical site. Their last semester students go to a hospital and a physician's office. Board members asked about concerns with exam rigor and what progress has been made. All faculty took an item writing and test evaluation course. Each faculty member is reviewing their specialty HESI and faculty is completing a test taking strategy course that they are integrating with their students. Their current student census is 125 with an expected class of 17 students to graduate in September 2014. There will be no graduating class in December 2014. Board members asked about action plans for each school. Staff indicated that faculty has to attend faculty orientation and the first day is student orientation which was implemented in June 2014. Staff indicated that has helped both faculty and students. Board members asked about administrative/corporate support. Staff indicated that they were recently able to obtain new equipment for the simulation lab with 2 advanced IV arms, another mannequin and a Sim Pad. There are not accepting new admissions at this time. They are retaining faculty and have had no turnover. They are in the process of hiring two additional faculty members. No Board vote was required at this time.

G. Everest College Closure Plan (Tracy Miller and Patricia Jones)

Staff appeared from Everest College regarding the closure of their campus and Nursing program. Board members had no concerns about the plan and the teach-out of the program. The campus will remain open an additional three months after the students complete courses for review and are purchasing review products for NCLEX preparation as well. The report did not address recordkeeping for student records. Record keeping will supplemented via a written notification with the location, name and pertinent information of the vendor. **Board Action: A motion was made and seconded to accept the closure plan with the recordkeeping provision. Ogle/Narwold, 8-0-0, motion carries**

She left her kids in the car when she went into the daycare center to get her swipe card. She states she could see the kids the whole time. CPS made her do a safety program. The following personal appearances took place on August 20, 2014 before ALJ Kim Cooper, RN:

1. Daniel Ullmer RN Exam CBC Hit/ Positive Response

Mr. Ullmer appeared for his personal appearance regarding his application for licensure. He graduated from nursing school in June 2014. His personal situation growing up was not ideal. Both of his parents were alcoholics. He was abandoned by his mother. He then had to go live with his father. His father did not take care of him so in order to take of himself and to get something to eat he committed some crimes. He was arrested for burglary (of a business). He spent 4 years in prison. After this he got married and had a child. Since that time he has had some minor brushes with the law. During his divorce he was charged with disorderly conduct. He was later remarried. He and his current wife were in an argument. He was charged with domestic disturbance. He also had an OWI. When he went to nursing school, he completed a criminal background check but never had to talk with anyone. He is not sure if this information was released to his clinical sites. Ms. Cooper recommends completion of an MMP-II. Once those results are returned to the Board, he will return for another personal appearance.

2. Chelsea Ray RN Exam CBC Hit

Ms. Ray appeared for her personal appearance regarding her application for licensure. She is currently licensed in the State of Ohio. What she completed on the application was not what showed up on her background check. Her lawyer told her she did not have to check yes. She was on break during nursing school. She had been at a friend's house and had some drinks. She decided to drive home. She was pulled over. She did not have a breathalyzer. The officers wanted to administer one but she declined since she had already told them she had been drinking. Ms. Cooper recommends the endorsement be granted. Her license is to be issued on probation until the conclusion of her criminal probation. She will need to send in quarterly employer reports during this time.

3. Angela Jones RN Exam Grad Date of May 2009 CONTINUED

4. June Arthur RN Exam Positive Response CONTINUED

5. Lauren Ross RN Exam CBC Hit

Ms. Ross appeared for her personal appearance regarding her application for licensure. She was not forthcoming on her application. Two summers ago she was in Nashville. She received a citation for a fake ID. When she went back for the court date she was informed the matter had been dismissed. She answered no on application because she was told the matter was cleared up. She was 20 at the time. Ms. Cooper recommends she be allowed to test. Upon successful completion of the NCLEX, her license is to be issued on probation for 6 months from the date she passes the test with quarterly reports.

6. Erin Cummings RN Exam Grad Date of June 2010

Ms. Cummings appeared for her personal appearance regarding her application for licensure. She finished her RN program in 2010. She has tested three times. She does not remember the last time she tested. She has taken a review course. They did not provide her with a predictability document. Ms. Cooper recommends she provide the proper documentation showing she received a 95% change or greater of passing. Once this is received, she will be allowed to test and upon successful passage of the NCLEX, the license will be issued free and clear.

7. Heath Davis LPN Endo CBC Hit/ Positive Response

Mr. Davis appeared for his personal appearance regarding his application for licensure. When he got out of the military he suffered PTSD and was not treated right away. He started abusing drugs. He is currently in the KARE program. He has had a positive drug test for alcohol since being in the program. He has been fully compliant since February 2014. He did have an arrest and had possession for numerous controlled substances. He is currently on criminal probation until 2016. Ms. Cooper recommends the endorsement be granted. His license is to be issued on probation for the length of his criminal probation. He needs to contact ISNAP and enter into an Out of State Monitoring Agreement.

8. Easel Lagmay LPN Endo CBC Hit

Ms. Lagmay appeared for her personal appearance regarding her application for licensure. She is currently licensed in California. In October 2013, she was arrested for theft at Wal-Mart. She was with another person. She distracted the Wal-Mart employee while the other person she was with left the store with the groceries. She has not had any issues before or since. Her criminal probation has ended. She did not disclose this information on her application. She states she answered no because she wasn't sure if it was talking about a misdemeanor or a felony. She claims she misread the application. Ms. Cooper recommends allow endorsement. Her license is to be issued on probation for nine months active practice with quarterly employer reports.

9. Li Tanya Hurdle LPN Endo CBC Hit/ Positive Response

Ms. Hurdle appeared for her personal appearance regarding her application for licensure. She is currently is licensed in Illinois. In 2005 she was arrested for giving false information. She thought she had a warrant out for her arrest so she gave a police officer her nickname

instead of her full name. She doesn't remember what happened as a result. In 2011, she was charged with reckless driving. She was driving home after working a 13 hour shift. She had not been drinking. In 2013, she received an OUI. She is on supervised criminal probation until February 2015. All this information was reported to Illinois. Ms. Cooper recommends the endorsement be granted. Her license is to be issued on probation for the length of her criminal probation. Quarterly employer reports are to be submitted.

10. Jawana Nicks RN Exam CBC Hit/ Positive Response

Ms. Nicks appeared for her personal appearance regarding her application for licensure. She was in a residence to pick up somebody. The police showed up and to serve warrants. There were multiple names on the lease so everyone at the apartment was arrested. They were all arrested for possession of marijuana. She did not have any marijuana on her but there was some in the house. There are criminal charges pending. She indicates that these charges should be dismissed on September 16, 2014. The only other time she has been in trouble was when she was 18. She bumped a car in the parking lot and did not leave a note. No alcohol was involved in this matter. Ms. Cooper recommends this matter be tabled due to open criminal charges. The matter is to be reset for October ALJ.

11. Anne Coyle RN Endo Positive Response

Ms. Coyle appeared for her personal appearance regarding her application for licensure. She currently has an Ohio license. She has been terminated from two positions. She first was licensed in October 2012. In May 2013, she gave too much insulin to a patient. She misread the order when she gave the medication. The patient was fine after precautions were taken when the mistake was realized. The second termination happened after a patient fell in the dining room and the fall resulted in a fracture. She had moved the patient to a supervised table but the alarm on her chair was not working. She was terminated for failing to follow physician orders, which were to have the alarm on. She is currently working and has not had any write ups or any trouble at this current job. Her current job is not a direct patient care role. She is an intake coordinator. This position requires an Indiana license due to the company having an Indiana office. Ms. Cooper recommends the endorsement be granted. Her license is to be issued on probation for a period of six months active practice with quarterly employer reports and completion of a total of nine CEUs with three in each of the following areas: assessment, medical administration, and critical thinking.

12. Deirdre Francis RN Exam Grade Date of June 2011

Ms. Francis did not appear for her personal appearance regarding her application for licensure. Ms. Cooper recommends this matter be rescheduled one time.

13. Scott Biro RN Endo CBC Hit/ Positive Response

Mr. Biro appeared for his personal appearance regarding his application for licensure. In 1999, he was charged with possession of marijuana. In 2002, 2004, and 2005, he had OWIs. He does not report having any issues with alcohol or substance abuse. Of the three OWIs the only one that resulted in injury was in 2002, and that was to himself. He cannot remember what his blood alcohol levels were except they were over .10. Ms. Cooper recommends the endorsement be granted. His license will be issued on probation. He needs to have six months active practice, quarterly employer reports, and an ISNAP evaluation. If he meets criteria for an ISNAP RMA his probation will be whichever is longer, six months of active practice or the length of the RMA.

14. Sheila Harris LPN Exam CBC Hit/ Positive Response

Ms. Harris appeared for her personal appearance regarding her application for licensure. She got into some trouble after shooting off a gun on July 4, 1994. She also had a warrant for her arrest for battery. Someone had pressed charges against her. Once she found out that there was a warrant for she turned herself in. These charges were dropped due to the other person lying. She has not had any other issues. Ms. Cooper recommends she be allowed to test. Her license is to be issued free and clear.

15. Leonard Ford LPN Exam CBC Hit/ Positive Response

Mr. Ford appeared for his personal appearance regarding his application for licensure. He graduated in 2012 but has never tested. He is currently working as a CNA. He was arrested in 2007 for marijuana. The court matter was resolved. He is currently taking a review course. Ms. Cooper recommends he be allowed to test. Upon successful completion of the NCLEX, his license is to be issued on probation for 6 months active practice with quarterly employer reports.

16. Cassandra Freestone RN Exam CBC Hit/ Positive Response

Ms. Freestone appeared for her personal appearance regarding her application for licensure. She went out after her last final in May to celebrate. She made the decision to drive after having some drinks. She was involved in an accident on the way home. She rear ended another car. She was attempting to pull off in a safe place and was pulled over. Her blood alcohol was .15. She was proactive regarding the victim impact panel and attended it before it was mandated. She is set for criminal trial on September 19, 2014 but is currently working on a plea agreement. Ms. Cooper recommends the matter to be tabled until October ALJ since the criminal matter is still open.

17. Katie Harper RN Exam Positive Response

Ms. Harper appeared for her personal appearance regarding her application for licensure. She was arrested for public intoxication in 2010. It happened a month after she turned 21. She was with some friends walking home. They were being loud and obnoxious. In 2007, she received a citation for drinking. She was 18 at the time. She has not had any other issues. Ms. Cooper recommends she be allowed to

test. Upon successful completion of the NCLEX, her license is to be issued free and clear.

Ms. Granger appeared for her personal appearance regarding her application for renewal. Her license expired at least two years ago and she has not worked on it since. When she first got the charge there was going to be a deferment charge, the court dates were changed several times, she missed the court date and a warrant was issued for her arrest. When she was made aware of the warrant she turned herself in. She was in jail for 48 hours. Previous to this the prosecutor had called her and told her that the drug program was taken off her sentence and told her she had to come up with the fine money. She asked the courts if she could take care of everything in Bloomington instead of Bedford. She went to Centerstone. She reported to a probation officer for several months in Bloomington. She received a call from the sheriff in Bedford stating there was a warrant for her arrest and skipping town. She explained that she had been doing everything in Bloomington. This matter has now been resolved. All of this started when the guy she was dating told her to hold his marijuana pipe when they were pulled over.


Ms. Cooper recommends her license be renewed on probation for nine months active practice with quarterly reports.


3. Heather Mohr EXP LPN Renewal Positive Response
