The board has no authority to recommend third party education evaluators.

DISCUSSION REGARDING ESTHETICS SALON REQUIREMENTS

1) The Board discussed salons that are individual suites dedicated solely to esthetic services in a building where there are no other practitioners, clients, or unrelated business activities occurring in the suite when a licensee is performing services on a client. The Board reviewed the administrative rules and determined that the administrative rules do not provide an exception for these types of one room suites to use their entire suite as the required separate room. All salons must have the separate room as required in 820 IAC 3-2-10.

2) The Board discussed salons that have architectural and HVAC challenges in meeting 820 IAC 3-2-10 Esthetics; separate room requirements. The Board reviewed the administrative rules and determined that the administrative rules do not provide an exception for the separate room surrounded by ceiling to floor walls and accessed only by doors that shall remain closed when esthetic services are being performed.
